Bond Ordinance 1.73

An Ordinance providing for the issue of not to exceed \$908,000 General Obligation Limited Tax Park Bonds, for park purposes, providing for the levy of a direct annual tax to pay the principal and interest on said bonds, authorizing the execution and delivery of a tax escrow agreement in connection with the said bonds, and authorizing the sale of said bonds to the purchaser thereof.

Commissioner Skelly has 100% confidence in the new executive director and her financial ability but voiced his concern of \$900,000 bond. He would like to see things paid down and eventually get smaller on the bonds. Commissioner Tucker asked if the bond is 3 years? It was explained the bond ordinance allows the district to sell bonds for three years not to exceed a total of 2 million. The \$908,000 is part of the 2 million that can be sold over 3 years. Commissioner Tucker and Skelly feels Splash Valley is a priority. The bond is not intended to fund the renovation/rebuild of splash valley. Grants and donations will have to fund splash valley. Commissioner Hollis explained we have not forgotten about splash valley but we need to have a full plan in order to seek funding outside of the tax levy. Nothing can be done until we have a plan. Commissioner Hollis and Commissioner Skelly continued to discuss their opinions of relying on grants, government, and outside funding.

A motion to approve the Bond Ordinance 1.73 was made by Commissioner Mullady, seconded by Commissioner Hollis. Upon roll call vote the following Commissioners voted aye: D. Tucker, M. Mullady, L. Cooper, A. Hollis. The following Commissioner voted nay: D. Skelly. With 4 ayes, 1 nay, motion carried.
