# **An Ordinance Amendment**

A motion to approve an ordinance amending an ordinance providing for the issue of not to exceed \$908,000 General Obligation Limited Tax Park Bonds, of the District for park purposes, providing for the levy of a direct annual tax to pay the principal and interest on said bonds, authorizing the execution and delivery of a tax escrow agreement in connection with said bonds, and authorizing the sale of said bonds to the purchase thereof by Commissioner D. Tucker, seconded by M. Mullady. Upon roll call vote the following Commissioners voted aye: A. Hollis, M. Mullady, D. Skelly, L. Cooper, D. Tucker. With 5 ayes, 0 nays, motion carried.

Dave Phillips from Speer Financial said the interest rate is outside of the parameter that was originally approved. Dave spoke to underwriting tonight, offer is good tonight but not beyond that. They have been aware of the newspapers and they are concerned of the district but understand there are different issues and the tax interceptor is positive. Commissioner Tucker asked what is the next step? Dave Phillips will call tonight and reaffirm. Attorney Coghlan has documents from Chapman and Cutler for signatures.

Commissioner Skelly thanked Dave Phillips for his hard work and diligence. The Last few weeks have been trying and appreciate Dave sticking with us.

Dave at Speer said he won't charge us for the work he did. The district can now moving in the right direction. There are some tough choices to be made by the Executive and the board.
