PUBLIC COMMENT

A motion to approve the Kankakee Youth Hockey League agreement was made by Commissioner Skelly, seconded by Commissioner Spriggs. Discussion: Director Heitz: No changes in terms and/or pricing from prior years. We are struggling with the Irish right now.

There is a teen drop on Friday night but a few of the Irish teen members get on the ice and do not pay and 2 of their coaches were conducting practice during that time. Apparently sneaking in has been an issue for a long time. They sneak in from the locker room. We are changing some policies with monitors, etc. We are going to be doing a retraining for all staff there. It will cover every aspect of each position. Commissioner Hollis said usually at a public events they get a wristband, is that something we have thought about? Yes. We are going to use wristbands for public skate. For drop in they will have to show us receipts. Commissioner Tucker asked about taking the receipts? That's a proof of purchase. Some people are sticklers for their receipt. Director Heitz said this is a different receipt so they are still getting the actual receipt. Upon roll call vote the following Commissioners voted aye: D. Skelly, D. Tucker, B. Spriggs, M. STAFF REPORTS

Executive Director

Director Heitz: We brought the phone and alarm system to you at the committee meeting. The phone service is a 3-year contract. They always have promos so at the most it would go up \$100. It also comes with a backup internet option. Since our server is here, we could continue to still be able to operate phone and computers. All locations would be on the same renewal schedule. Protection Associates is looking into lowering some 911 rates. They did a fire alarm test this week. They hadn't done one in a couple years. It is about \$1000 that we didn't anticipate. They were honest and upfront about it. We will code this to contingency.

Will be placing an ad for staff at Ice Valley. Need people over 21 years of age to work concessions.

We hope to know about funding for Splash Valley and we hope to know in a couple weeks. Commissioner Hollis would like to know who got the bid package. Just want to make sure local banks were given a chance to bid on it. Commissioner Skelly wants it financed either way but would certainly like to see it funded by a local bank.

Would like to discuss the 2 architects; Farnsworth and Williams. Williams quoted us for the assessment and full engineering project. Without the assessment we do not know where we

stand on major mechanical, building and piping issues as well and IDPH. The initial analysis with Williams is very different from that of Farnsworth. Farnsworth will cost more however they have IDPH field reviews, document any permitting issues, and talk about what needs to be removed and what can stay. Commissioner Hollis asked where Williams Architects is located. Itasca and Chicago. They came and did the initial presentation a year ago. Farnsworth analysis is stated to be more in depth. Commissioner Hollis clarified the 2 proposals. What are we getting more from Farnsworth rather than Williams to make up for that cost? Can we ask Williams to add IDPH and see how much is it going to cost? Can we ask Farnsworth to narrow down the not to exceed pricing to a realistic amount for us to compare? Commissioner Skelly said we can tell you are getting a better vibe from Farnsworth. You have the experience in aquatics. We will trust your judgement. Would still like to see an advisory board to give the public some say. Commissioner Hollis stated we should give regular updates to the public once the project is started.

We have staff meetings scheduled this week.

Meeting with the farmer that takes care of the fields near Ice Valley this week. Will be meeting about River Road bathrooms this week. Meeting Gerry Gund this week. All supervisors meeting next week. Closed Monday for the holiday. Will be taking some time off in the next couple weeks.
