OLD BUSINESS

Housing Authority

Attorney Coghlan served a 30-day notice to Housing Authority. There has been correspondence between the Attorneys lawyer. They have interest in purchasing the property. In the process

The structure is not ours, the building is deeded and owned by the Housing Authority. They would have to remove it or leave it if we choose to evict. Commissioner Palmer said the board back then had a fiduciary obligation to the park district and not the organization. Attorney Coghlan said the board thought it was beneficial to the community at that time. Attorney Coghlan said the preliminary discussion has been to buy the land for \$10,000 or provide a statement to show what their revenue was. Commissioner Skelly said send the letter to evict. Attorney Coghlan said the date is actually November 1. Served them on September 19th. Bring it for an action meeting at a Special Meeting before the October Committee Meeting.

Commissioner Spriggs doesn't want maintenance mowing that area. Commissioner Hollis asked if the district uses that area for our use? Attorney Coghlan said majority of that area is used for parking. Next year Director Heitz is hoping to get more tournaments and the parking is vital. Attorney Coghlan said the original agreements were signed a long time ago. If the park district doesn't want to mow it, we will mow it and then charge the District for parking. Commissioner Skelly said we need an agreement. Commissioner Spriggs said we have enough parks to cut. Attorney Coghlan will have the agreement done by the next Committee meeting. Director Heitz said we will continue to cut it until the next Committee Meeting. It can be an action item.

45/52 Sign

This is considered a monument to them. We are going to try to redesign our sign as to not disturb theirs. Director Heitz has planned to charge them rent to keep it there. Commissioner Palmer said it costs money to advertise and they are using that sign to advertise. Attorney Coghlan said we have to go to the zoning committee to get it approved. There are hoops we have to jump through to get this done. Director Heitz said once we know it's legal, we will know how we can proceed with the sign.
