NEW BUSINESS

A. Approval of Standard Form of Agreement between the Park District, as Owner, and Construction Manager, Leopardo Companies, Inc., as Constructor where the basis of payment is the cost of work plus a fee with a Guaranteed Maximum Price of \$1,720,899 for the Splash Valley Renovation Project.

Director Heitz: Working with our attorney on going out to bid and the AIA has been reviewed and amended by our attorney. The pricing is lower because it's for the construction and does not include the items we removed from the budget. A motion to approve the standard form of agreement between Park District and Leopardo was made by Commissioner Skelly, seconded by Commissioner Spriggs.
