OLD BUSINESS

Piggush Engineering - Neil Piggush - Update on Harbor

Neil Piggush- Passed out a layout for the proposed reconstruction of the harbor. Put our heads together to better use the area since we will have to reconstruct everything from scratch. Trying to cut costs on the project. Running floating docks north and south. Ended up with 70 slips. Would have to construct north and east wall that would cut our wall length in half. New layout has one centralized location for people to enter. Looked at existing pedestrian bridge and it's in rough shape. In the event you need to repair a floating dock, the entire is not out of service. Everything would rise with the river level. The east wall on the dock would be replaced and would widen the walks along the wall. They would be 8-foot walks. Commissioner Skelly asked why you would get rid of the benches? Mr. Piggush said they can stay. We were just trying to centralize the entrance to harbor and keep people away from the edge of the river. This was just our first stab and layout and thinks it's more efficient. Commissioner Eads asked for your best estimate on construction of east wall, how to get funding? Mr. Piggush ran some numbers on the east wall. Think anywhere between 150,000-200,000. Still looking at structural options. 8-foot concrete wall. Looking to see what's most economical. The July meeting will have more a refined answer and this layout will be more defined. 240 feet of wall. Commissioner Skelly asked if it's the existing wall? Mr. Piggush would be concerned with leaving what is there. Wouldn't want to guarantee anything because you can't see everything. Commissioner Skelly asked if the new configuration versus the old, have you looked at what we would have to buy versus what we have? Mr. Piggush will get back to us. Commissioner Spriggs asked when the harbor could be back up and running? Mr. Piggush said there are lots of factors but thinks the east wall could get out to bid in fairly short order. He said we could put that as an alternative in the bid.

Approval of Surplus Equipment (ACTION)

NEW BUSINESS

County Chairman Wheeler – Present Potawatomi Boat Launch Dredging Project 2023

Andy Wheeler (via Zoom): Appreciate your time and consideration. Devoting a million-dollar allocation to cleaning out the boat launch area in Aroma Park. Rescue boats and residents can get in the water there. We need your participation and help with this, not monetary. On a commission that is working to keep the sand out of the river. Never going to have enough money for the big fix but will have some for other smaller projects. The launch in Aroma has sand. We are looking to get into the river and get the sand out of there. The county is going to invest into equipment to help deal with that moving forward. We will dredge as much as the million dollars will take us. Where will we dewater of the sand before its disposed? The parking lot you have there would be perfect. It would allow the water to go back into the river. Asking for approval to use that parking lot to dewater the sand and then it can be hauled out. We are in the planning stages now but hope to have this done by this time next year. We have to be able to get rescue boats into the water. Commissioner Spriggs asked how much you'll pull out and how much on the parking lot? Chairman Wheeler said whatever million dollars can get it, is how we are limited. Commissioner Spriggs asked how long will the sand have to sit there? Chairman Wheeler said it wouldn't be for a year or even a month. Commissioner Palmer asked if there would be any damage to the parking lot but see the wisdom in using our facility. All Commissioners are in favor of this.

Speer Financial Planning Packet for Review

D. Heitz said it's strictly for review. Aaron Gold with Speer will come in July or August to discuss.

Superintendent of Buildings/Grounds

Rick Collins: Started to add mulch in 6 playgrounds already. Started to break down Bird Park field. Still doing construction/taking out asphalt at Washington and added more employees. Commissioner Spriggs asked about the timeline for Washington? Rick said we are trying to get it done as soon as possible. Hope to get done this week with getting the concrete out. Then will be dirt and grass seed. Commissioner Eads asked about the door at River Road? Rick said we are still waiting on that door. Commissioner Spriggs asked if Ariana has been over to the maintenance to look at the OSHA violations. Garbage cans and it's unsafe. Gas cans out and inside. Not sure what OSHA looks for but need to do a general clean up.

Superintendent of Business

Melissa Woodard: Audit field work is scheduled for end of July. Working through new employee paperwork and hoping to find a streamlined process to make ourselves more efficient.

Superintendent of Recreation

Lisa Krenkel: River Road hosted state and our staff ran concessions. \$7,000 over 2 weekends in sales. Ice Valley is getting new ice and maintenance. Hired a new athletic manager and he started last week. Comes with great experience from Southland.

Executive Director

Dayna Heitz: Have figured out our schedule for pool and will open Wednesday and Sunday 12-7 and other days 12-6. Availability has been hard with the guards. Commissioner Eads thanked Rick and Mike for getting the pool open.
