Motion to ratify change order for River Road improvement in the amount of \$45,438

A motion to ratify change order for River Road improvement in the amount of \$45,438 was made by Commissioner Eads, seconded by Commissioner Skelly. Discussion: Director Heitz said the work has already been started as this was approved. Received 3 Commissioners approval. Upon roll call vote the following Commissioners voted aye: R. Eads, J. Frey, M. Matthews, D. Palmer, D. Skelly.

Motion to ratify approval for constructing a parking lot at Steve Hunter park with KVCC in the amount of \$18,529

A motion to ratify approval for constructing a parking lot at Steve Hunter Park with KVCC in the amount of \$18,529 was made by Commissioner Matthews, seconded by Commissioner Eads. Discussion: Commissioner Frey asked about the differences for the new and old proposal. Director Heitz said the original proposal was \$45,000 without engineering and we would have had to go out to bid and have engineering. Commissioner Matthews said this could be done in phases if deemed necessary. Commissioner Skelly said it's a neighborhood park. Commissioner Palmer said a larger parking lot would become a gathering place instead of the park. Upon roll call vote the following Commissioners voted aye: R. Eads, M. Matthews, D. Palmer, D. Skelly. Abstain: J. Frey

Motion to approve D Construction change order for Beckman Harbor East wall not to exceed the amount of \$50,000 for PZ 27 temporary sheet pile

A motion to approve D Construction change order for Beckman Harbor East wall not to exceed the amount of \$50,000 for PZ 27 temporary sheet pile was made by Commissioner Eads, seconded by Commissioner Skelly. Discussion: Director Heitz discussed the change order. They have to put in temporary pilings to work behind and put the pilings in due to the rock. Commissioner Skelly asked why that wasn't known when they put the bid. Director Heitz said borings didn't show it. The money will come from capital. Upon roll call vote the following Commissioners voted aye: R. Eads, J. Frey, M. Matthews, D. Palmer, D. Skelly.

Discussion of Civic Auditorium replacement furnaces

Director Heitz said we went back to the drawing board. Contacted Doug Bright and his mechanical engineer spent a couple hours with us. If we were to redo the full HVAC system, it will be approximately 1.25 million. That doesn't include the architecture and engineering. Brought up the park grant and wanted to check with Upland. It's too quick to put this together. If it's something the board wants to do, we can plan for it another year. \$29,500 would be to replace the 2 furnaces. Commissioner Frey would like to get some other people to look at it. Rick said it's been hard to get quotes because they all want engineers and architects to look at it. Commissioner Eads thinks we should go ahead with getting the 2 fixed. Then at least we have that locked in. Commissioner Palmer agrees. Can add to agenda next meeting. All Commissioners agree.

Discussion of Decennial Committee on local government efficiency act meeting

Director Heitz wanted to make sure everyone received the email and the meeting is Tuesday, May 30th at 4pm.

Discussion of walking path renovations (Gov. Small, Old Fair, Washington)

Director Heitz said we will be getting a quote for Gov. Small and should have that later by end of month. For walking path renovation, we will start with Gov. Small.
