Discussion: Commissioner Skelly stated that it seems that we are putting a lot of money into the compressors again and we have, over the last 5-10 years. Rick Collins said we use them all year long and it's just normal wear and tear. When purchased new, they have a 2-year warranty. The rebuild is only 1 year. We will be rebuilding. Commissioner Skelly asked what the cost is to get a new instead of rebuild. Director Heitz said we are waiting for that quote. The liners and
