CONSENT AGENDA

OLD BUSINESS

Update of Bird Park Project

Innovation Landscape is completing punch list items. Once those are completed, Upland Design will sign off. Any Retainage will be billed and paid to complete the project.

Update on Mayor R.J. Bailey Park Renovation Project

Finalize schedule, KVPD Maintenance was responsible for removing shelter/benches. KVPD has been informed that we will be required to do a survey of the riverbank area where the canoe launch to determine if any endangered species (mussel) would be affected. Work will begin on the removal of trees to access river and for the concrete walkway to be completed.

Cemetery Plan (Discussion)

Executive Director Bruni stated that he had contacted Dawn Cobb with IDNR regarding the cemetery out by Splash Valley. The information she provided was forwarded to the Board. Discussion on what KVPD next steps were. KVPD will begin the process of clearing brush, and overgrown areas in November when the vegetation season ends. Per IDNR, only hand tools are to be used and no penetrating the surface to avoid disturbing any sites. KVPD will follow protocols outlined by IDNR in the event any remains are discovered. Once a determination of the condition is made, KVPD will develop a plan of action for future upkeep. The perimeter fence has been secured to prevent access.

National Fitness Campaign Grant (DISCUSSION)

Executive Director Bruni stated that in following up on the Grant, KVPD investment was larger than previously discussed. Additionally, it was discovered that Kankakee High School was in the process of completing the installation of the same project. At this time, it was recommended to decline allocating resources since there is the amenity already available in town.
