**Electronic Delivery (e-delivery).** I hereby authorize ETC Brokerage Services ("ETCBS") to electronically deliver my Account documents to the e-mail address provided above. Such Account documents include:

- Account Statements
- Reports
- Statutory and Summary Prospectuses
- Shareholder Reports
- Proxy materials, and
- Other legally required notices

In order to obtain such Account information electronically, I must maintain a **valid e-mail address** with ETCBS and have access to a computer with internet service to retrieve the documents through a secure account login. By consenting to e-delivery of documents, I agree to receive any or all of the above-listed communications and statements through e-delivery. I will only receive an e-mail notification with regard to an equity security or mutual fund if I hold a position in such asset(s) as of the record date for a particular shareholder communication and the materials are made available electronically by the issuer or third party. If an issuer or third party does not make shareholder materials available electronically, I will receive paper documents via U. S. mail at no additional charge to me.

E-mail notification and electronic documents may be made available in either HTML or PDF format. If I use spam-blocking software, I will update my settings to accept e-mail from ETCBS. Electronic documents may be viewed electronically via the Web and printed with a local printer. They may also be saved to a local hard drive. In order to view, print, save, store or download e-mail notifications and/or electronic documents, the latest version of a web browser with Java Script enabled will be required. To access any PDF format documents, Adobe Acrobat Reader is needed, which can be downloaded for free at any time (see [www.adobe.com](http://www.adobe.com)).

**Materials Issued by Third Parties.** The content of the shareholder materials provided to me is the responsibility of the issuing corporation, mutual fund, securities issuer or other third party who is making those materials available. ETCBS is not responsible for the content of electronic documents which were not drafted or generated by ETCBS.

**Paper Delivery.** I may request a paper version of any document at any time by calling: (877) 403-0369 or by accessing my account online. A fee may apply for each paper copy of any document I request.

**Valid E-Mail Address.** I must provide a valid e-mail address and any subsequent updates thereto to ETCBS in order to obtain e-delivery of such documents. I agree to immediately notify ETCBS of any change in my e-mail address that I have provided. I may provide such notification to ETCBS either:

- (i) Via e-mail at [ETCBrokerage@ETCBrokerage.com](mailto:ETCBrokerage@ETCBrokerage.com);
- (ii) Fax: 440-366-3753; or
- (iii) In the ONLINE DOCUMENT section of your ONLINE trading account.

Communications sent by ETCBS to the e-mail address I provide shall, until notice of a different address is received by ETCBS, be deemed to have been personally delivered to me whether actually received or not.

**Notices.** If a message to my e-mail address is returned due to an unsuccessful delivery, I will receive a written notice through the U.S. mail. The notice will state that my ETCBS Account communications are available online and I will be asked to provide an updated e-mail address. Upon ETCBS's second failed attempt to e-mail me, ETCBS will mail a second notice similar to the above. Concurrent with the second notice, ETCBS will discontinue e-delivery and forward communications through the U.S. mail on a going forward basis and my Account will be charged an annual fee equal to **\$30**.

**Withdrawal.** I may withdraw my consent to e-delivery at any time either:

- (ii) Fax: 440-366-3753; or
- (iii) In the ONLINE DOCUMENT section of your ONLINE trading account.

If I withdraw such consent, ETCBS will resume mailing paper copies the month following that in which the next Account document or communication is generated and an annual fee equal to **\$30** will be charged to my Account.
