This form is required along with a copy of the filed court order (i.e., filed divorce decree, QDRO) and must be signed by the Account Holder and the former spouse. Additional forms are also needed as indicated based on transfer instructions. Submit all necessary documentation to Equity Institutional, a division of Equity Trust Company.
