ACCESS WAIVER & RELEASE

Use of the Green County Family YMCA Fitness Center during unstaffed hours is for Green County Family YMCA members only. To be eligible for 24/7 access, members must be over 18 years old, have a photo on file and have purchased a key fob. Each family member over 18 must purchase their own 24/7 access key fob to gain access to the Green County Family YMCA Fitness Center. Members found abusing this policy will have their 24/7 access revoked and may possibly lose their YMCA membership.

By signing this form, members understand that the Green County Family YMCA may, from time to time, perform a criminal background check if the need arises. The Green County Family YMCA reserves the right to revoke 24/7 access and deactivate the key fob of any member at any time for any reason.

The Green County Family YMCA recommends that each member work out with a partner who also has 24/7 access to the Fitness Center when working out during unstaffed hours. Although the Green County Family YMCA has taken certain steps to ensure member safety, the Green County Family YMCA cannot be held responsible for any accident or injury suffered by members while working out during unstaffed hours alone.

By signing this form, members understand and agree to hold harmless the Green County Family YMCA if accident or injury is suffered while in the Fitness Center including, but not limited to: loss of consciousness, stroke, heart attack, fall, broken bone or concussion. The Green County Family YMCA will not be able to offer First-Aid or CPR to members during unstaffed hours. The Green County Family YMCA advises members to speak to their doctor before beginning any exercise regimen. By signing this form, members are agreeing to use the Fitness Center at their own risk. The Green County Family YMCA is not responsible for any lost or stolen items.

This waiver and release of liability includes, without limitation, all injuries which may occur, regardless of negligence, as a result of; (a) The use of all amenities and equipment in the Fitness Center during unstaffed hours; (b) The sudden and unforeseen malfunctioning of any equipment; (c) Any slip and/or fall while on the Green County Family YMCA premises, including adjacent sidewalks and parking areas.

By signing this form, members understand that snow removal will not be enforced during unstaffed hours. Members with 24/7 access choose to visit the Fitness Center at their own risk.

By signing this form, members acknowledge that they have carefully read this waiver and release and fully understand the information provided therein.

I agree to release and discharge the Green County Family YMCA, its employees, stakeholders, representatives and agents from any and all claims or causes of action. I agree to voluntarily give up or waive any right that I may otherwise have to bring any legal action against the Green County Family YMCA for negligence, personal injury or property damage suffered by me during unstaffed hours.

Should any part of this agreement be found by a court of law to be against public policy or in violation of any state statute, only the section found to be in violation will be removed.
