FINANCIAL SECTION

Town of Mt. Crested Butte, Colorado Management's Discussion and Analysis

The Management Discussion and Analysis (MD&A) is designed to provide an easy-to-read discussion of the Town's financial condition and operating results and to disclose to the reader important financial activities and issues related to the Town's basic operations. The MD&A should be read in conjunction with the Town's basic financial statements.

The Town has one financial category - government-type activities. Within the government type activities, the Town Council has designated several separate funds including a General Fund and several Special Revenue Funds. The government type activities are funded primarily through the Town's sales and use taxes, specific ownership taxes, grants and contributions, charges for services and ad-valorem property tax.

Financial Highlights

- 2017 Sales Tax collections reached an all-time high of \$2,568,716.
- 2017 Summer Sales Tax Revenues have increased every year since 2009.
- 2017 The Admissions Tax Fund spent \$571,917 on marketing and events.
- 2017 The Admissions Tax collections reached an all-time high of \$840,304.
- 2017 General Fund revenues were \$525,735 above expenditures.

Using This Annual Report

This annual report consists of three required parts – *management's discussion and analysis* (this section), the *basic financial statements*, and *required supplementary information*. The basic financial statements include two kinds of statements that present different views of the Town:

- The first two statements are *government-wide financial statements* that provide both *long-term* and *short-term* information about the Town's overall financial status.
- The remaining statements are *fund financial statements* that focus on *individual parts* of the Town government, reporting the Town's operations *in more detail* than the government-wide statements.

The basic financial statements also include *notes* that explain some of the information in the financial statements and provide more detailed data. The statements are followed by a section of *required supplementary information (RSI)* that further explains and supports the information in the financial statements.

Following the *RSI* are additional statements that are required by oversight agencies but are not a required part of the financial statement under generally accepted accounting principles.

Government-wide Statements

The government-wide statements consist of the Statement of Net Position and the Statement of Activities. These statements report information about the Town as a whole and include *all* assets and liabilities using the accrual basis of accounting, which is similar to the accounting used by most private-sector companies. All of the current year's revenues and expenses are taken into account regardless of when cash is received or paid.

These two statements report the Town's net position and changes in them. The Town's net position – the difference between assets and liabilities – is one way to measure the Town's financial health, or *financial position*. Over time, increases or decreases in the Town's net position is one indicator of whether its financial health is improving or deteriorating. Other non-financial factors, however, such as changes in the Town's property tax base are needed to assess the overall health of the Town.

Fund Financial Statements

The fund financial statements provide more detailed information about the Town's funds, focusing on its most significant funds – not the Town as a whole.

Governmental funds – All of the Town's activity is reported in governmental funds, which focuses on how money flows into and out of each of the funds and the balances left at year-end that are available for use in future years. These funds are reported using an accounting method called modified accrual accounting, which measures cash and all other financial assets that can readily be converted to cash. The governmental fund statement provides a detailed short-term view of the Town's general governmental operations and the basic services it provides. Governmental fund information helps to determine whether there are more or fewer financial resources that can be spent in the near future to finance the Town's programs.

Along with the fund financial statements, a reconciliation is provided to reconcile the fund financial statements with the applicable government wide financial statement.

STATEMENTS OF NET POSITION

The perspective of the statement of net position is of the Town as a whole. Following is a summary of the Town's net position for 2017 and 2016:

The Town's Funds

The Town's governmental funds as presented on page 6 reported a combined fund balance of \$5,823,069. Of this amount \$1,504,929 was in the General Fund, \$2,905,486 in the Downtown Development Fund and \$432,344 in the Admissions Tax Fund. In 2017 the Town's General Fund transferred \$252,000 to the Capital Projects Fund for 2017 Capital Projects.

General Fund Budgetary Highlights

During the year, the Town's revenues from sales taxes were \$2,568,716 which was \$194,403 above the 2017 Budget and 10.64% above 2016 actual sales tax collections. The building permit revenues which include use tax, building permits and design review revenues were \$333,166 and \$23,166 above the budget. Total General Fund revenues were \$100,088 above budget and expenditures were \$181,530 below budget.

ECONOMIC AND OTHER FACTORS

The major industry in Mt. Crested Butte is winter and summer tourism. Sales Taxes account for 54% of the Town's General Fund Revenues and the other major revenues are property taxes and building revenues. Summer and Winter Sales Tax collections have been increasing steadily for the last five years. Building revenues continue to outpace the Town's normal 5-year average and we expect them to remain strong over the next couple of years. The Town recently updated its five-year plan. One of the plans main objectives is to maintain the General Fund balance at 50% of operating expenditures and any funds over the 50% are transferred to the Capital Fund to cover all capital expenditures such as road repairs, recreation path extension, the purchase of capital equipment and a new maintenance facility. The General Fund will transfer approximately \$3,078,000 over the next 5 years to the Capital Fund for Capital Expenditures. The 5-year plan sees property taxes increasing 3% in 2018, and 10% in 2020. Sales taxes in the plan will increase 3% per year for 2018 thru 2022.

Minimum Revenue Guarantees to airlines continues to be extremely important to supporting our tourism economy. For the summer of 2018 the Gunnison Valley Rural Transportation Authority will be supporting direct flights from Houston, Texas to Gunnison/Crested Butte County Airport. Then, for the 2018-2019 winter ski season direct flights will be supported from both Houston, Texas and Dallas/Ft. Worth, Texas. Additionally, the Gunnison/Crested Butte County Airport receives year around United Airlines service from Denver, Colorado.

Fat biking, winter mountain biking, is a growing winter sport. In January of 2016 Mt. Crested Butte hosted the First Annual Fat Bike Worlds inviting industry representatives, sport promoters, and fat bike enthusiasts. The event was extremely successful and continues as an annual January event.

Additionally, Crested Butte Mountain Resort continues to improve their summer tourism product by annually adding new mountain biking trails on Crested Butte Mountain. Both mountain biking and road biking are increasing in popularity and they are a major "Adventure Travel" attraction to our destination year around resort. The Tourism Association began promoting Gunnison County's 750 miles and 150 trails of Mountain Biking in the spring of 2015 (www.mtbhome.com). This focus on Mountain Biking plus a growing number of Summer Events continue to fuel our growing summer tourism business.

The Gothic Trail Phase II began construction in August of 2016 with the aid of a Federal Grant, Transportation Alternative Program. This recreation trail extension supports both summer biking and winter fat biking as well as providing a concrete recreation path from Winterset Drive in Mt. Crested Butte to Elk Avenue in Crested Butte connecting our two communities via nonmotorized route allowing our citizens and tourist visitors to enjoy the mountain scenery away from traffic. The total bid to construct the trail was \$1,657,555 and the Federal Grant awarded was \$922,884. The Gothic Trail work was completed in 2017 and the Town has requested the remaining \$104,615 of the grant.

In March of 2018 the Town of Mt. Crested Butte was awarded an Energy and Mineral Impact Assistance Grant from the Colorado Department of Local Affairs in the amount of \$746,619 to fund approximately 50% of the cost of constructing a new maintenance facility for our community. The 8,100-square foot facility is scheduled to break ground during the summer of 2018. Mt. Crested Butte capital funds will support the balance of the construction costs.

Independent Auditors' Report

Report on the Financial Statements

We have audited the accompanying financial statements of the governmental activities, the business-type activities, each major fund, and the aggregate remaining fund information of the Town of Mt. Crested Butte, Colorado, as of and for the year ended December 31, 2017, and the related notes to the financial statements which collectively comprise the basic financial statements of the Town, as listed in the table of contents.

Management's Responsibility for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America; this includes the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of the financial statements that are free from material misstatement, whether due to fraud or error.

Auditors' Responsibility

Our responsibility is to express opinions on these financial statements based on our audit. We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Those standards require that we plan and perform the audit to obtain reasonable assurance about whether the financial statements are free of material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statements. The procedures selected depend on the auditor's judgment, including the assessment of the risks of material misstatement of the financial statements, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the entity's preparation and fair presentation of the financial statements in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity's internal controls. Accordingly, we express no such opinion. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluating the overall presentation of the financial statements.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinions.

Opinion

In our opinion, the financial statements referred to above present fairly, in all material respects, the respective financial position of the governmental activities, the business-type activities, each major fund, and the aggregate remaining fund information of the Town of Mt. Crested Butte, Colorado, as of December 31, 2017, and the respective changes in financial position and, where applicable, cash flows, thereof, for the year then ended in conformity with accounting principles generally accepted in the United States of America.

Report on Summarized Comparative Information

We have previously audited the Town of Mt. Crested Butte's 2016 financial statements, and we expressed an unmodified audit opinion on those audited financial statements in our report dated April 3, 2017. In our opinion, the summarized comparative information presented herein as of and for the year ended December 31, 2016 is consistent, in all material respects, with the audited financial statements from which it has been derived.

Emphasis of Matter

As discussed in Note 11 to the financial statements, the 2016 financial statements have been restated to reflect the reclassification of the Town's accrued vacation liability from a current to a noncurrent liability. Our opinion is not modified with respect to this matter.

Other Matters

Required Supplementary Information – Management's Discussion and Analysis

Accounting principles generally accepted in the United States of America require that the management, discussion and analysis on pages M1 – M6 be presented to supplement the basic financial statements. Such information, although not a part of the basic financial statements, is required by the Governmental Accounting Standards Board who considers it to be an essential part of financial reporting for placing the basic financial statements in an appropriate operational, economic, or historical context. We have applied certain limited procedures to the required supplementary information in accordance with auditing standards generally accepted in the United States of America, which consisted of inquiries of management about the methods of preparing the information and comparing the information for consistency with management's responses to our inquiries, the basic financial statements, and other knowledge we obtained during our audit of the basic financial statements. We do not express an opinion or provide any assurance on the information because the limited procedures do not provide us with sufficient evidence to express an opinion or provide any assurance.

Required Supplementary Information – Budgetary Comparison Schedules and Other Supplementary Information

Our audit was conducted for the purpose of forming an opinion on the financial statements as a whole. Accounting principles generally accepted in the United States of America require that the budgetary comparison schedules shown on pages 29 - 33 be presented to supplement the basic financial statements. Such information, although not a part of the basic financial statements, is required by the Governmental Accounting Standards Board who considers it to be an essential part of financial reporting for placing the basic financial statements in an appropriate operational, economic, or historical context. The combining and budgetary comparison statements and schedules listed as other supplementary information pages 34 – 43 are presented for purposes of additional analysis and are not a required part of the financial statements. This information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. Such information has been subjected to the auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the basic financial statements or to the financial statements themselves, and other additional procedures in accordance with auditing standards generally accepted in the United States of America. In our opinion, the information is fairly stated, in all material respects, in relation to the financial statements as a whole.

Report on Other Legal and Regulatory Requirements

Our audit was conducted for the purpose of forming an opinion on the financial statements as a whole. The Local Highway Finance Report page 44 - 45 is presented for purposes of legal compliance and is not a required part of the financial statements. NOTE 1: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

HISTORY AND FUNCTION OF ORGANIZATION

The Town of Mt. Crested Butte is a municipal home rule government governed by a council – manager form of government. The Town is a political subdivision of the State of Colorado governed by a seven member board of trustees. The Town is a full service entity providing public safety, public works, and parks services.

REPORTING ENTITY

In accordance with Governmental Accounting Standards, the Town has considered the possibility of inclusion of additional entities in its basic financial statements. The definition of the reporting entity is based primarily on financial accountability. The Town is financially accountable for organizations that make up its legal entity. It is also financially accountable for legally separate organizations if Town officials appoint a voting majority of the organization's governing body and either it is able to impose its will on that organization or there is a potential for benefits to, or to impose specific financial burdens on, the Town. The Town may also be financially accountable for governmental organizations that are fiscally dependent upon it.

Based upon the application of these criteria, there is one component unit over which the Town exercises significant influence which is the Downtown Development Authority. Significant influence or accountability is based primarily on operational or financial relationships with the Town (as distinct from legal relationships). This component unit is reported as a blended component unit special revenue fund of the Town.

GOVERNMENT-WIDE AND FUND FINANCIAL STATEMENTS

The government-wide financial statements (i.e., the statement of net position and the statement of activities) report information on all of the activities of the Town. Governmental activities, which normally are supported by taxes and intergovernmental revenues, are reported separately from business-type activities, which rely to a significant extent on fees and charges for support.

The statement of activities demonstrates the degree to which the direct expenses of the given function or segment are offset by program revenues. Direct expenses are those that are clearly identifiable with a specific function or segment. Program revenues include 1) charges to customers or applicants who purchase, use, or directly benefit from goods, services, or privileges provided by a given function or segment and 2) grants and contributions that are restricted to meeting the operational or capital requirements of a particular function or segment. Taxes and other items not properly included among program revenues are reported instead as general revenues.

Separate financial statements are provided for governmental and fiduciary funds. Major individual funds are reported as separate columns in the fund financial statements.

MEASUREMENT FOCUS AND BASIS OF ACCOUNTING

The government-wide financial statements are reported using the *economic resources measurement focus* and the *accrual basis of accounting*, as are the proprietary fund financial statements. Revenues are recorded when earned, and expenses are recorded when a liability is incurred, regardless of the timing of the related cash flows. Property taxes are recognized as revenues in the year for which they are levied. Grants and similar items are recognized as revenue as soon as all eligibility requirements imposed by the provider have been met.

Governmental fund financial statements are reported using the *current financial resources measurement focus* and the *modified accrual basis of accounting*. Under the modified accrual basis of accounting, revenues are recognized when susceptible to accrual (i.e., when they become both measurable and available). "Measurable" means the amount of the transaction can be determined. "Available" means collectible within the current period or soon enough thereafter to be used to pay liabilities of the current period. For this purpose, the Town considers revenues to be available if they are collected within 60 days of the end of the current fiscal period. Expenditures are recorded when the related fund liability is incurred. Exceptions to this general rule include: (1) principal and interest on general long-term debt which is recognized when due and (2) compensated absences which are recognized when the obligations are expected to be liquidated with expendable available resources.

Those revenues susceptible to accrual are sales taxes, property taxes, franchise fees, interest earned and grants. Other revenues are not susceptible to accrual as they generally are not measurable until received in cash.

FUND ACCOUNTING

The accompanying financial statements include the Town's governmental fund types and fiduciary fund. The Town's accounting system is organized and operated on a fund basis. A fund is defined as a fiscal and accounting entity with a self-balancing set of accounts recording cash and other financial resources, together with all related liabilities and residual equities or balances, and changes therein, which are segregated for the purpose of carrying on specific activities or attaining certain objectives in accordance with special regulations, restrictions, or limitations.

Governmental Fund Types

Governmental funds are those through which most governmental functions of the Town are financed. The acquisition, use and balances of the Town's expendable financial resources and the related liabilities (except those related to the operation of the sewer system) are accounted for through governmental funds. The measurement focus is on determination of changes in financial position, rather than on a computation of net income. The following are the Town's governmental fund types:

Governmental Fund Types (Continued)

General Fund

This fund is the Town's primary operating fund. It accounts for all financial resources of the general government, except those required to be accounted for in another fund taxes. Principal expenditures are for police protection, public works, parks and recreation and Town administration.

Special Revenue Funds

These funds account for revenues derived from specific taxes or other designated revenues that are legally restricted to expenditures for specific purposes. The Town's major special revenue funds are as follows:

Admissions Tax Fund

This fund accounts for the admissions tax revenues that are set aside to support the Town's marketing, event sponsorship and transportation needs.

Transportation Fund

This fund accounts for the sales and use tax revenues that are set aside to support the Town's transportation needs.

Downtown Development Authority

This fund accounts for the Town's blended component unit, the Downtown Development Authority.

Capital Projects Funds

The Town's capital projects funds account for revenues derived from dedicated mill levies and impact fees or other designated revenues that are to be used for capital purposes. The Town tracks its revenue from each type of impact fee, but is not obligated to spend such revenue immediately; in other words, it can build up reserves in order to have the cash available for large-scale projects. Expenditures from each fund are narrowly tailored to the type of fee collected, and consist of either "hard" costs (i.e. capital improvements or vehicle/equipment acquisitions), or "soft" costs relating to planning or engineering of hard costs, which can be a permissible use of impact fee revenue. The Town's major capital projects fund is as follows:

Capital Fund

This fund accounts for the financial resources and expenditures of the Town's mill levy restricted for capital projects and equipment.

Governmental Fund Types (Continued)

Debt Service Funds

These funds account for resources that are accumulated for the repayment of the Town's and Downtown Development Authority's outstanding debt. These funds receive transfers from restricted resources accounted for in other funds in order to satisfy the current obligation.

DDA Debt Service Fund

This fund accounts for the resources transferred from the Downtown Development Authority to be used for repayment of the 2007 Tax Increment Revenue Bonds.

Fiduciary Fund

Fiduciary funds are used to account for the Town's activities held in a fiduciary capacity. The Town's fiduciary fund is as follows:

Police Pension Fund

This fund accounts for the Town's Police Pension Fund. This fund was established by Resolution 9, Series 1984 by the Town under C.R.S 31-30-301 for the benefit of police officers only in the event of disability while in the performance of their duties. The fund was created as a result of a distribution from the Fire and Police Pension Association. Revenues of the fund consist solely of interest earnings. The fund does not pay benefits upon retirement but instead will be used for death and disability benefits for current officers.

BUDGETS AND BUDGETARY ACCOUNTING

Budgets were adopted for all funds except for the fiduciary fund which does not anticipate expenditures. Budgets are prepared on the same basis of accounting as that used for accounting purposes. In the budget versus actual statements, the actual results of operations are presented on the budgetary basis of accounting for proper comparison to the budget.

Budgets are adopted based on the requirements of state statutes. The following timetable is used:

- 1) Submission of the proposed budget to the Board of Trustees by October 15 of each year.
- 2) Certification of mill levies to the County Commissioners by December 15 of each year.
- 3) Final adoption of the budget and appropriations by December 31 of each year.

The Town does not use encumbrance accounting and all appropriations lapse at year end.

Deposits and Investments

The Town's cash and cash equivalents are considered to be cash on hand, demand deposits, and short-term investments with original maturities of three months or less from the date of acquisition. State statutes govern the Town's deposits of cash and investments.

Investments consist of certificates of deposit. The Town does not make a distinction between cash and investments in the fund financial statements.

Cash and Equivalents

The Town's cash and cash equivalents are considered to be cash on hand, demand deposits, and certificates of deposit with original maturities of one year or less from the date of acquisition. State statutes govern the Town's deposits of cash and investments.

Accounts Receivable and Allowance for Doubtful Accounts

Governmental Funds - At December 31, 2017, the Town had no significant past due accounts receivable. In estimating the allowance for doubtful accounts management reviews each past due balance and evaluates the likelihood of eventual collection. If an account is deemed uncollectable and should be written off, it is taken to the Board of Trustees for approval. At December 31, 2017, the Town did not consider any allowance necessary.

Capital Assets

Capital assets, which include property, plant, and equipment, are reported in the government-wide financial statements. Capital assets are defined by the government as assets with an initial individual cost of more than \$5,000 and an estimated useful life in excess of three years. Such assets are recorded at historical cost or estimated historical cost if not purchased or constructed. The costs of normal maintenance and repairs that do not add to the value of the asset or materially extend assets lives are not capitalized. Infrastructure is being recorded and depreciated on a prospective basis at historical cost.

Property, plant and equipment of the Town is depreciated using the straight-line method over the following estimated useful lives:

Buildings and improvements	25 - 40 years
Vehicles	5 years
Heavy equipment	7 – 10 years
Office furniture and equipment	5 – 10 years
Infrastructure	10 - 50 years

Governmental Activities

Expenditures for capital assets are recorded as expenditures in the appropriate governmental fund. They are also reported in the governmental activities column of the government-wide financial statements. These assets are reported at cost, or at fair market value in the case of donated assets.

Capital Assets (Continued)

Depreciation has been provided in the government-wide financial statements and has been computed as described above. Depreciation is not provided in the fund financial statements.

Accumulated Unpaid Leave (Compensated Absences)

Vacation, compensated absences and that portion of sick leave expected to be paid in the following year (if any) are recorded as activity level liabilities. At December 31, 2017 the amount of this accrued liability was \$187,076.

Vacation

The Town has the following policy for compensated vacation pay.

Sick Leave

Sick leave is granted to employees on the basis of 8 hours for each month worked. Upon termination employees are paid 1 day of sick pay for every 3 days of unused sick leave.

Because it is not expected that a significant portion of sick leave will be used in any given year, sick leave is generally not recorded as a fund liability but is included as a noncurrent liability in the Statement of Net Position. The only exception to this policy is in the event that an employee(s) with unusually large accumulated sick pay benefits terminate and it is known that their benefits will be paid out in the near future

Deferred Inflows of Financial Resources

In addition to liabilities, the statement of net position will sometimes report a separate section for deferred inflows of resources. This separate financial statement element, deferred inflows of resources, represents an acquisition of net position that applies to a future period(s) and will not be recognized as an inflow of resources (revenue) until that time. The government has only one type of item, which arises both under the full accrual and modified accrual basis of accounting that qualifies for reporting in this category. Accordingly, the item, unavailable revenue, is reported in both the governmental activities statement of net position and in the governmental funds balance sheet. The governmental funds report unavailable revenues from property taxes. These amounts are deferred and recognized as an inflow of resources in the period that the amounts become available. Since property tax revenues are collected in arrears during the succeeding year, a receivable and corresponding deferred inflow is recorded at December 31. As the tax is collected in the succeeding year, the deferred inflow is recognized as revenue and the receivable is reduced.

Long-term Obligations

In the government-wide financial statements long-term debt and other long-term obligations are reported as liabilities in the applicable activity section of the Statement of Net Position.

Net Position/Fund Balances

In the government-wide financial statements, net position is either shown as invested in capital assets net of related debt, with these assets essentially being nonexpendable; restricted when constraints placed on the net position are externally imposed; or unrestricted.

For the governmental fund presentation, fund balances that are classified as “nonspendable” include amounts that cannot be spent because they are either (a) not in spendable form or (b) legally or contractually required to be maintained intact. The “not in spendable form” criterion includes items that are not expected to be converted to cash, for example, inventories and prepaid amounts.

Fund balance is reported as “restricted” when constraints placed on the use of resources are either (a) externally imposed by creditors (such as through debt covenants), grantors, contributors, or laws or regulations of other governments; or (b) imposed by law through constitutional provisions or enabling legislation.

Amounts that can only be used for specific purposes pursuant to constraints imposed by the most formal action, adoption of an ordinance, of the government's highest level of decision-making authority, the Board of Trustees, are reported as “committed” fund balance. Those committed amounts cannot be used for any other purpose unless the government removes or changes the specified use by taking the same type of action (for example, legislation, resolution, ordinance) it employed to previously commit those amounts.

Amounts that are constrained by the government's intent to be used for specific purposes, but are neither restricted nor committed, are reported as “assigned” fund balance. Intent should be expressed by (a) the governing body itself or (b) a body (a budget or finance committee, for example) or official to which the governing body has delegated the authority to assign amounts to be used for specific purposes.

All remaining fund balance in the General Fund or deficits in the other governmental funds are presented as unassigned.

NET POSITION/FUND BALANCE FLOW ASSUMPTIONS

Sometimes the government will fund outlays for a particular purpose from both restricted and unrestricted resources (the total of committed, assigned, and unassigned fund balance). In order to calculate the amounts to report as restricted, committed, assigned, and unassigned fund balance in the governmental fund financial statements a flow assumption must be made about the order in which the resources are considered to be applied. It is the government's policy to consider restricted fund balance to have been depleted before using any of the components of unrestricted fund balance, if allowed under the terms of the restriction. Further, when the components of unrestricted fund balance can be used for the same purpose, committed fund balance is depleted first, followed by assigned fund balance. Unassigned fund balance is applied last.

REVENUES AND EXPENDITURES

Program Revenues

Amounts reported as program revenues include 1) charges to customers or applicants who purchase, use, or directly benefit from goods, services, or privileges provided by a given function or segment and 2) grants and contributions (including special assessments) that are restricted to meeting the operational or capital requirements of a particular function or segment. All taxes, including those dedicated for specific purposes, and other internally dedicated resources are reported as general revenues rather than as program revenues.

Property Taxes

Property taxes attach as an enforceable lien on property as of January 1. Taxes may be paid in two equal payments. To avoid penalties, the first half must be paid before March 1, and the second half must be paid on or before June 15. Alternatively, the taxes may be paid in full by April 30. All unpaid tax becomes delinquent June 16. Property taxes are levied and collected on behalf of the Town by Gunnison County and are reported as revenue when received by the County Treasurer.

Property taxes which have been levied for 2017 and will not be collected until 2018 have been accrued as a receivable at December 31, 2017. An offsetting deferred inflow of resources has been recorded in each of the affected funds.

USE OF ESTIMATES

The preparation of basic financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

CONCENTRATIONS

As a result of the Town's proximity to Crested Butte Mountain Resort, it has been able to rely on sales and admissions tax to provide a significant amount of the revenue needed for the governmental operations of the Town. In addition, the property values in the Town are relatively high as a result of this same proximity. The Town's ability to continue operations at its current level using sales and admissions tax revenue and property taxes is dependent on the continued success of Crested Butte Mountain Resort.

COMPARATIVE DATA

Comparative total data for the prior year has been presented in most of the accompanying financial statements in order to provide an understanding of changes in the Town's financial position and operations. However, comparative (i.e., presentation of prior year totals by fund type) data has not been presented in certain statements since their inclusion would make those statements unduly complex and difficult to read.

NOTE 2: CASH AND INVESTMENTS

Deposits

Custodial Credit Risk - Deposits

In the case of deposits, this is the risk that in the event of bank failure, the government's deposits may not be returned to it. The Town's deposit policy is in accordance with CRS 11-10.5-101, The Colorado Public Deposit Protection Act (PDPA), which governs the investment of public funds. PDPA requires that all units of local government deposit cash in eligible public depositories. Eligibility is determined by state regulations. Amounts on deposit in excess of federal insurance levels must be collateralized by eligible collateral as determined by the PDPA. The financial institution is allowed to create a single collateral pool for all public funds held. The pool is to be maintained by another institution, or held in trust for all the uninsured public deposits as a group. The market value of the collateral must be at least equal to 102% of the uninsured deposits. The institution's internal records identify collateral by depositor and as such, these deposits are considered uninsured but collateralized. The State Regulatory Commissions for banks and financial services are required by statute to monitor the naming of eligible depositories and reporting of the uninsured deposits and assets maintained in the collateral pools.

At December 31, 2017, all of the Town's deposits as shown below were either insured by federal depository insurance or collateralized under PDPA and are therefore not deemed to be exposed to custodial credit risk.

Investments

Credit Risk - Investments

Colorado statutes specify which instruments units of local government may invest, which include:

- Obligations of the United States and certain U.S. government agency securities
- Certain international agency securities
- General obligation and revenue bonds of the U.S. local government entities
- Bankers' acceptances of certain banks
- Commercial paper
- Local government investment pools
- Written repurchase agreements collateralized by certain authorized securities
- Certain money market funds
- Guaranteed investment contracts

The Town's investment policy limits its investments to those allowed by Colorado Revised Statute 24-75-601.1 as described above.

Investments (Continued)

Concentration of Credit Risk - Investments

The Town places limits on the amount that may be invested in any one issuer. The Town did not hold any non-bank investments at year end.

Interest Rate Risk - Investments

Colorado Statutes require that no investment may have a maturity in excess of five years from the date of purchase. The Town does not have an investment policy that further restricts investment maturities.

Custodial Credit Risk – Investments

For an investment, custodial credit risk is the risk that, in the event of the failure of the counterparty, the Town will not be able to recover the value of its investments or collateral securities that are in the possession of an outside party. As of December 31, 2017, the Town did not hold any non-bank investments.

Bonds Payable

2007 Tax Increment Revenue Bonds dated January 25, 2007. The purpose of the bonds was to finance improvements to the downtown area. Interest ranges from 4.25% to 4.40%. Interest payable semi annually in June and December. Principal due annually in December through 2018. These bonds were issued by the Mt. Crested Butte Downtown Development Authority with payments made by the DDA Debt Service Fund funded through a transfer from the Downtown Development Authority.

2010 Sales and Use Tax Revenue Bonds dated March 23, 2010. The purpose of the bonds is to finance various infrastructure improvements. Interest at 5.25%. Interest is payable semi annually in June and December. Principal is payable annually in December through 2030. These bonds were issued by the Town with payments made by the Debt Service Fund funded through a transfer from the Capital Fund.

NOTE 5: COMMITMENTS AND CONTINGENCIES

The Town receives financial assistance from federal and state governmental agencies in the form of grants. The disbursement of funds received under these programs generally requires compliance with terms and conditions specified in the grant agreements and are subject to audit by the grantor agencies. Any disallowed claims resulting from such audits could become a liability of the General Fund or other applicable funds. However, in the opinion of the Town, any such disallowed claims will not have a material effect on any of the financial statements of the individual fund types included herein or on the overall financial position of the Town at December 31, 2017.

NOTE 6: RESTRICTED FUND BALANCE / NET POSITION

Tax Spending and Debt Limitations

On November 3, 1992, the voters of Colorado approved Amendment 1, commonly known as the TABOR Amendment, which adds a new Section 20 to Article X of the Colorado Constitution. TABOR contains tax, spending, revenue and debt limitations which apply to the State of Colorado, all local governments, and special districts. The Town's financial activity for the year ended December 31, 2017 will provide the basis for calculation of future limitations adjusted for allowable increases tied to inflation and local growth.

Subsequent to December 31, 1992, revenue in excess of the Town's "spending limit" must be refunded unless voters approve the retaining of such excess revenue. TABOR generally requires voter approval for any new tax, tax increases and new debt.

At an April 5, 1994 election, the Town passed the following ballot question:

Shall the Town of Mt. Crested Butte be authorized to collect and increase fiscal year spending such that the full revenues generated during 1993 and each subsequent year thereafter by its existing sales and use tax and from all other sources other than municipal taxes, without any increase in sales and use tax rates, to be expended without limitation under Article. X, Section 20 of the Colorado Constitution, for (a) snow removal; (b) street sweeping; (c) street construction, repair, and maintenance (d) capital improvements; (e) police protection; (f) storm drainage; (g) parks and recreation; (h) transportation; and (i) other municipal services; and without limiting in any year the amount of other revenues that may be collected and spent by the Town of Mt. Crested Butte under Article X, Section 20, of the Colorado Constitution, or any other law, provided that there shall be no increase in the Town's existing sales and use tax rates unless approved by a majority of the Town of Mt. Crested Butte voters voting on any such proposed increase?

In addition, at an April 4, 2000 election, the Town passed the following ballot question:

SHALL THE TOWN OF MT. CRESTED BUTTE, COLORADO, TAXES BE INCREASED \$245,000.00 IN THE FIRST FISCAL YEAR (2001) AND ANNUALLY THEREAFTER IN SUCH AMOUNTS AS ARE RECEIVED EACH YEAR BY THE IMPOSITION OF AN ADDITIONAL MILL LEVY, NOT TO EXCEED FIVE (5) MILLS, UPON TAXABLE PROPERTY WITHIN THE TOWN, COMMENCING WITH TAX YEAR 2000, AND CONTINUING THEREAFTER, SUCH REVENUES TO BE COLLECTED, RETAINED, AND SPENT FOR THE PURPOSES OF DEFRAYING SALARY EXPENSES OF THE TOWN OF MT. CRESTED BUTTE POLICE DEPARTMENT AND OTHER TOWN OF MT. CRESTED BUTTE EMPLOYEES, ACQUISITION OF EQUIPMENT, AND/OR OTHER LAWFUL MUNICIPAL PURPOSES, AS A VOTER APPROVED REVENUE CHANGE AND AN EXCEPTION TO THE LIMITS WHICH WOULD OTHERWISE APPLY UNDER ARTICLE X, SECTION 20, OF THE COLORADO CONSTITUTION OR ANY OTHER LAW?

The Article requires an emergency reserve be set aside for 2017 in the amount of 3 percent or more of its fiscal year spending. At December 31, 2017, the Town has reserved the following for emergencies:

NOTE 7: RISK MANAGEMENT

The Town is involved with the Colorado Intergovernmental Risk Sharing Agency (CIRSA), a separate and independent governmental and legal entity formed by intergovernmental agreement by member municipalities pursuant to the provision of 24-10-115.5, Colorado Revised Statutes (1982 Replacement Volume) and Colorado Constitution, Article XIV, Section 18(2).

The purposes of CIRSA are to provide members defined liability and property coverages and to assist members to prevent and reduce losses and injuries to municipal property and to persons and property which might result in claims being made against members of CIRSA, their employees and officers.

It is the intent of the members of CIRSA to create an entity in perpetuity which will administer and use funds contributed by the members to defend and indemnify, in accordance with the bylaws, any member of CIRSA against stated liability of loss, to the limit of the financial resources of CIRSA. It is also the intent of the members to have CIRSA provide continuing stability and availability of needed coverages at reasonable costs. All income and assets of CIRSA shall be at all times dedicated to the exclusive benefit of its members.

CIRSA is a separate legal entity and the Town does not approve budgets nor does it have ability to significantly affect the operations of the unit.

The Town has not materially changed its coverage from previous years. Based on the lack of previous loss occurrences, the Town has not recorded any liability for unpaid claims at December 31, 2017.

Health Insurance

NOTE 8: RETIREMENT COMMITMENTS

Defined Contribution Plan

The Town has adopted a defined contribution plan for all salaried employees. Participation in the plan is mandatory for covered employees. The fund is named Colorado County Officials and Employees Retirement Association. Employees vest in the Town's contribution at 20% per year. All salaried employees who have contributed to the plan are entitled to the benefits after completion of one year of service and upon termination. The employee contributes 8% of earnings and employer contributes 10% of earnings. The Town is not liable for amounts over the 10%. All contributions were current. During 2017, the Town contributed \$127,006 and the employees contributed \$101,604. The Town's total payroll is \$1,045,799 of which \$1,281,186 or 99% is covered under the plan.

Under the plan employees may also contribute to a deferred compensation plan (457 plan). Employee contributions during 2017 were \$25,592.

NOTE 9: INTERFUND TRANSACTIONS

The Town and Downtown Development Authority have recorded routine operating transfers from operating funds to debt service funds to provide resources for current fiscal year bond payments. In addition, the Town transferred \$442,000 from the General Fund to the Capital Fund to provide funding for current and future capital activities.

NOTE 10: JOINT VENTURE

The Town participates in a joint venture with its neighbor, the Town of Crested Butte. The joint venture, Mountain Express, provides a bus service to the ski area and throughout the towns. The Mountain Express Board has final authority for all budgeting and financing of the joint venture. The joint venture issues a separate set of financial statements that can be obtained from Mountain Express. Under terms of the joint venture agreement the Town of Mt. Crested Butte pays 95% of 1% of the Town's sales tax to the joint venture.

NOTE 11: PRIOR PERIOD RESTATEMENT

For the December 31, 2016 financial statement presentation, the Town reported \$114,432 of accrued vacation balances in the General Fund. It has been determined that this balance should be reflected as a non-current liability in the governmental activities as it is not expected to be liquidated with current resources. Accordingly, the General Fund net position has been increased as of December 31, 2016 by \$114,432. There was no impact on the governmental activities net position.
