

A RESOLUTION APPROVING AN EXEMPTION FROM AUDIT FOR THE CALENDAR YEAR 2016 FOR THE RENDEZVOUS COMMERCIAL METROPOLITAN DISTRICT LOCATED IN GRAND COUNTY IN THE STATE OF COLORADO.

WHEREAS, the Board of Directors of the Rendezvous Commercial Metropolitan District wishes to claim exemption from the audit requirements of Section 29-1-603, C.R.C.; and

WHEREAS, Section 29-1-604, C.R.S. states that any local government where neither revenues nor expenditures exceed five hundred thousand dollars may, with the approval of the state auditor, be exempt from the provisions of Section 29-1-603, C.R.S.; and

WHEREAS, neither revenues nor expenditures for the Rendezvous Commercial Metropolitan District exceeded \$100,000 for the calendar year 2016; and

WHEREAS, an application for exemption from audit for the Rendezvous Commercial Metropolitan District has been prepared by Thomas E. Whyte, treasurer, a person skilled in governmental accounting; and


WHEREAS, said application for exemption from audit has been completed in accordance with regulations issued by the state auditor.
