

**RESOLUTION FOR EXEMPTION FROM AUDIT
(Pursuant to Section 29-1-604, C.R.S.)**

A Resolution approving an exemption from audit for the fiscal year 2016 for the Cory Cemetery District, State of Colorado.

Whereas, the Board of Directors of the Cory Cemetery District wishes to claim exemption from the audit requirements of Section 20-1-603, C.R.S.; and

Whereas, Section 29-1-604, C.R.S., states that any local government where neither revenues nor expenditures exceed seven hundred and fifty thousand dollars may, with the approval of the State Auditor, be exempt from the provision of Section 29-1-603, C.R.S.; and


Whereas, neither revenue nor expenditures for the Cory Cemetery District exceeded \$100,000 for Fiscal Year 2016; and

Whereas, an application for exemption from audit for the Cory Cemetery District has been prepared by Lesley R. Lewis, a person skilled in governmental accounting, and


Whereas, said application for exemption from audit has been completed in accordance with regulations, issued by the State Auditor.

Now therefore, be it resolved by the Board of Directors of the Cory Cemetery District that the application for exemption from audit for the Cory Cemetery District for the Fiscal Year 2016, has been personally reviewed and is hereby approved by a majority of the Board of Directors of the Cory Cemetery District; that those members of the Board of Directors have signified their approval by signing below; and that this resolution shall be attached to, and shall become a part of, the application for exemption from audit of the Cory Cemetery District for the Fiscal Year Ended December 31, 2016.
