(Pursuant to Section 29-1-604, C.R.S.)

A RESOLUTION/ORDINANCE APPROVING AN EXEMPTION FROM AUDIT FOR FISCAL YEAR 2016 FOR THE FAIRVIEW CEMETERY DISTRICT, CHEYENNE COUNTY, STATE OF COLORADO.

WHEREAS, the Board of Directors of the Fairview Cemetery District wishes to claim exemption from the audit requirements of Section 29-1-603, C.R.S.; and

WHEREAS, Section 29-1-604, C.R.S., state that any local government where neither revenues or expenditures exceed one hundred thousand dollars may, with the approval of the State Auditor, be exempt from the provision of Section 29-1-603, C.R.S.; and

WHEREAS, neither revenue or expenditures for the Fairview Cemetery District exceeded \$100,000 for the Fiscal year 2016; and

WHEREAS, an application for exemption from audit for the Fairview Cemetery District has been prepared by Richard Ball, an independent accountant with knowledge of governmental accounting; and

WHEREAS, said application for exemption from audit has been completed in accordance with regulations, issued by the State Auditor.

NOW THEREFORE, be it resolved/ordered by the Fairview Cemetery Board of the Fairview Cemetery District that the application for exemption from audit for the Fairview Cemetery District for the Fiscal Year ended 12/31/2016, has been personally reviewed and is hereby approved by a majority of the Fairview Cemetery Board of the Fairview Cemetery District; that those members of the Fairview Cemetery Board have signified their approval by signing below; and that this resolution shall be attached to, and shall become a part of, the application for exemption from audit of the Fairview Cemetery District for the fiscal year ended December 31, 2016.
