WHEREAS, the Board of the Hinsdale County IOOF Cemetery District wishes to claim exemption from the audit requirement of Section 29-1-603, C.R.S.; and




WHEREAS, said application for exemption from audit has been completed in accordance with regulations, issued by the State Auditor.
