

A RESOLUTION/ORDINANCE APPROVING AN EXEMPTION FROM AUDIT FOR FISCAL YEAR 2016 FOR THE **Central Yuma GWMD**, STATE OF COLORADO.

WHEREAS, the **Board of Directors of the Central Yuma GWMD** wishes to claim exemption from the audit requirements of Section 29-1-603, C.R.S.; and

WHEREAS, Section 29-1-604, C.R.S., states that any local government where neither revenues nor expenditures exceed five hundred thousand dollars may, with the approval of the State Auditor, be exempt from the provision of Section 29-1-603, C.R.S.; and

WHEREAS, neither revenue nor expenditures for **Central Yuma GWMD** exceeded \$100,000 for Fiscal Year 2016; and

WHEREAS, an application for exemption from audit for **Central Yuma GWMD** has been prepared by **John R Willard**, a person skilled in governmental accounting;

NOW THEREFORE, be it resolved/ordained by the **Board of Directors of the Central Yuma GWMD** that the application for exemption from audit for **Central Yuma GWMD** for the Fiscal Year ended December 31, 2016, has been personally reviewed and is hereby approved by a majority of the **Board of Directors of the Central Yuma GWMD**; that those members of the **Board of Directors** have signified their approval by signing below; and that this resolution shall be attached to, and shall become a part of, the application for exemption from audit of the **Central Yuma GWMD** for the fiscal year ended December 31, 2016.
