RESOLUTION/ORDINANCE FOR EXEMPTION FROM AUDIT
(Pursuant to Section 29-1-604, C.R.S.)

A **RESOLUTION/ORDINANCE** approving an exemption from audit for fiscal year **2016** for the **North Kiowa-Bijou Groundwater Management District**, State of Colorado.

WHEREAS, the **Board of Directors** of the **North Kiowa-Bijou Groundwater Management District** wishes to claim exemption from the audit requirements of Section 29-1-603, C.R.S.; and

WHEREAS, Section 29-1-601, C.R.S., states that any local government where neither revenues nor expenditures exceed \$500,000 may, with the approval of the State Auditor, be exempt from the provision of Section 20-1-603, C.R.S.; and

WHEREAS, neither revenue nor expenditures for the **North Kiowa-Bijou Groundwater Management District** exceeded \$100,000 for the Fiscal Year of **2016**; and

WHEREAS, an Application for Exemption from Audit for the **North Kiowa-Bijou Groundwater Management District** has been prepared by **Andrew F. McClary** a person skilled in governmental accounting; and

WHEREAS, said Application for Exemption from Audit has been completed in accordance with regulations, issued by the State Auditor.
