

WHEREAS, the Board of Supervisors of the Eagle County Conservation District wishes to claim exemption from the audit requirements of Section 29-1-603. C.R.S.; and

WHEREAS, Section 29-1-604 C.R.S., states that any local government where neither revenues nor expenditures exceed five hundred thousand dollars may, with the approval of the State Auditor, be exempt from the provision of Section 29-1-603, C.R.S.; and


WHEREAS, neither revenue nor expenditures for the Eagle County Conservation District exceeded \$100,000 for Fiscal Year 2016; and

WHEREAS, said application for exemption from audit has been completed in accordance with regulations, issued by the State Auditor.






