A RESOLUTION APPROVING AN EXEMPTION FROM AUDIT FOR FISCAL YEAR 2016 FOR THE **SOUTH SIDE CONSERVATION DISTRICT**, STATE OF COLORADO,

WHEREAS, the **SOUTH SIDE CONSERVATION DISTRICT**, wishes to claim exemption from the audit requirements of Section 29-1-603, CRS; and

WHEREAS, the Section 29-1-604, CRS, states that any local government where neither revenues nor expenditures exceed five hundred thousand dollars may, with the approval of the State Auditor, be exempt from the provision of Section 29-1-603, CRS; and

WHEREAS, neither revenue nor expenditures for **SOUTH SIDE CONSERVATION DISTRICT** exceed \$100,000 for the fiscal year 2016; and

WHEREAS, an application for exemption from audit for the **SOUTH SIDE CONSERVATION DISTRICT** has been prepared by Sharie Prow, a person skilled in governmental accounting; and

WHEREAS, said application for exemption from audit has been completed in accordance with regulations, issued by the state auditor.






