(Pursuant to Section 29-1-604, C.R.S)

A RESOLUTION APPROVING AN EXEMPTION FROM AUDIT FOR FISCAL YEAR 2016 FOR THE *SAN LUIS VALLEY GIS/GPS AUTHORITY*, STATE OF COLORADO.

WHEREAS, the *SAN LUIS VALLEY GIS/GPS AUTHORITY* wishes to claim exemption from the audit requirements of Section 29-1-603, C.R.S.; and

WHEREAS, Section 29-1-604, C.R.S. states that any local government where neither revenues nor expenditures exceed seven hundred and fifty thousand dollars may, with the approval of the state auditor, be exempt from the provision of Section 29-1-603, C.R.S.; and


WHEREAS, neither revenues nor expenditures for *SAN LUIS VALLEY GIS/GPS AUTHORITY* exceeded \$100,000 for fiscal year 2016; and

WHEREAS, an application for exemption from audit for *SAN LUIS VALLEY GIS/GPS AUTHORITY* has been prepared by *Pete Magee*, a person skilled in government accounting; and


WHEREAS, said application for exemption from audit has been completed in accordance with regulation issued by the state auditor.
