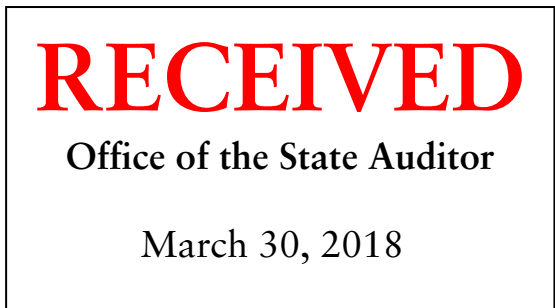

#### Policy - Requirements
