WHEREAS, THE HUERFANO PARKS AND RECREATION DISTRICT wishes to claim exemption from the audit requirements of 29-1-603,C.R.S and

WHEREAS, 29-1-604, C.R.S states that any local government where neither revenues nor expenditures exceed five hundred thousand dollars may, with the approval of the State Auditor, be exempt from the provision of 29-1-603,C.R.S

WHEREAS, neither revenues nor expenditures for HUERFANO PARKS AND RECREATION DISTRICT exceeded \$100,00 for Fiscal Year 2017 and

WHEREAS, an application for exemption from audit for HUERFANO PARKS AND RECREATION DISTRICT has been prepared by Cindy Campbell, CPA a person with knowledge of governmental accounting; and

WHEREAS, said application for exemption from audit has been completed in accordance with regulations, issued by the State Auditor.
