A RESOLUTION APPROVING AN EXEMPTION FROM AUDIT FOR FISCAL YEAR 2018

WHEREAS, the Haymeadow Metropolitan District No. 5 (the "District") is a quasi-municipal corporation and political subdivision of the State of Colorado and a duly organized and existing District pursuant to Title 32, Colorado Revised Statutes; and

WHEREAS, the District wishes to claim exemption from the audit requirements of §29-1-603, C.R.S.; and

WHEREAS, §29-1-604, C.R.S., states that any local government where neither revenues nor expenditures exceed seven hundred fifty thousand dollars may, with the approval of the state auditor, be exempt from the provisions of §29-1-603, C.R.S., and

WHEREAS, neither revenues nor expenditures for the District exceeded \$750,000 for fiscal year 2018; and

WHEREAS, an application for exemption from audit for the District has been prepared by Kenneth J. Marchetti, CPA, an independent accountant with knowledge in governmental accounting; and

WHEREAS, said application for exemption from audit has been completed in accordance with regulations issued by the state auditor.


NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of the Haymeadow Metropolitan District as follows:

1. The application for exemption from audit for the District for fiscal year ended December 31, 2018 has been reviewed and is hereby approved by a majority of the Board of Directors of the District.

5. This Resolution shall take effect and be enforced immediately upon its approval by the District Board.


