(Pursuant to Section 29-1-604, C.R.S.)

A RESOLUTION APPROVING AN EXEMPTION FROM AUDIT FOR FISCAL YEAR 2018 FOR THE **Eckley Rural Cemetery District** STATE OF COLORADO.

WHEREAS, the **Board of Directors** of the **Eckley Rural Cemetery District** wishes to claim exemption from the audit requirements of Section 29-1-603, C.R.S.; and

WHEREAS, Section 29-1-604, C.R.S., states that any local government where neither revenues nor expenditures exceed seven hundred fifty thousand dollars may, with the approval of the State Auditor, be exempt from the provision of Section 29-1-603, C.R.S.; and




WHEREAS, neither revenue nor expenditures for the **Eckley Rural Cemetery District** exceeded \$100,000 for Fiscal Year 2018; and

WHEREAS, an application for exemption from audit for the **Eckley Rural Cemetery District** has been prepared by **Samuel B Lewis** an accountant with knowledge of governmental accounting; and

WHEREAS, said application for exemption from audit has been completed in accordance with regulations, issued by the State Auditor.
