## RESOLUTION FOR EXEMPTION FROM AUDIT

(Pursuant to Section 29-1-604, C.R.S.)

A RESOLUTION APPROVING AN EXEMPTION FROM AUDIT FOR FISCAL YEAR 2018 FOR THE **Central Yuma GWMD**, STATE OF COLORADO.

WHEREAS, the **Board of Directors** of the **Central Yuma GWMD** wishes to claim exemption from the audit requirements of Section 29-1-603, C.R.S.; and

WHEREAS, Section 29-1-604, C.R.S., states that any local government where neither revenues nor expenditures exceed five hundred thousand dollars may, with the approval of the State Auditor, be exempt from the provision of Section 29-1-603, C.R.S.; and






WHEREAS, neither revenue nor expenditures for the **Central Yuma GWMD** exceeded \$100,000 for Fiscal Year 2018; and

WHEREAS, an application for exemption from audit for the **Central Yuma GWMD** has been prepared by **John R. Willard**, a person skilled in governmental accounting; and

WHEREAS, said application for exemption from audit has been completed in accordance with regulations, issued by the State Auditor.

NOW THEREFORE, be it resolved by the **Board of Directors** of the **Central Yuma GWMD** that the application for exemption from audit for the **Central Yuma GWMD** for the Fiscal Year ended December, 2018, has been personally reviewed and is hereby approved by a majority of the **Board of Directors** of the **Central Yuma GWMD**; that those members of the **Board of Directors** have signified their approval by signing below; and that this resolution shall be attached to, and shall become a part of, the application for exemption from audit of the **Central Yuma GWMD** for the fiscal year ended December, 2018.
