WHEREAS, said application for exemption from audit has been completed in accordance with regulation issued by the state auditor;

NOW THEREFORE, be it resolved by the EXECUTIVE BOARD of the SAN LUIS VALLEY COUNCIL OF GOVERNMENTS that the application for exemption from audit for SAN LUIS VALLEY COUNCIL OF GOVERNMENTS for the fiscal year ended DECEMBER 31, 2019, has been personally reviewed and is hereby approved by a majority of the EXECUTIVE BOARD of the SAN LUIS VALLEY COUNCIL OF GOVERNMENTS;

That those members of the EXECUTIVE BOARD have signified their approval by signing below; and that this resolution shall be attached to, and shall become a part of the application for exemption from audit of the SAN LUIS VALLEY COUNCIL OF GOVERNMENTS for the fiscal year ended December 31, 2019.
