WHEREAS, an application for exemption from audit for RWAPA will be prepared by Eric Weaver, an accountant with knowledge in governmental accounting; and

WHEREAS, said application for exemption from audit will be completed in accordance with regulations issued by the state auditor.

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of the RWAPA as follows:

1. The application for exemption from audit for RWAPA for fiscal year ended December 31, 2019 will be reviewed and is hereby approved by a majority of the Board of Directors of RWAPA.
2. The majority of the Board of Directors of RWAPA shall signify their approval by signing below.
3. This Resolution shall be attached to, and become a part of, the application for exemption from audit of RWAPA for the fiscal year ended December 31, 2019.
4. If any part, section, subsection, sentence, clause or phrase of this Resolution is for any reason held to be invalid, such invalidity shall not affect the validity of the remaining provisions.
5. This Resolution shall take effect and be enforced immediately upon its approval by the RWAPA Board.
