Office of the State Auditor — Local Government Division - Exemption Form Electronic Signatures Policy and Procedures

Policy - Requirements

The Office of the State Auditor Local Government Audit Division may accept an electronic submission of an application for exemption from audit that includes governing board signatures obtained through a program such as DocuSign or Echosign. Required elements and safeguards are as follows:

- The preparer of the application is responsible for obtaining board signatures that comply with the requirement in Section 29-1-604 (3), C.R.S., that states the application shall be personally reviewed, approved, and signed by a majority of the members of the governing body.
- The application must be accompanied by the signature history document created by the electronic signature software. The signature history document must show when the document was created and when the document was emailed to the various parties, and include the dates the individual board members signed the document. The signature history must also show the individuals' email addresses and IP address.
- Office of the State Auditor staff will not coordinate obtaining signatures.

The application for exemption from audit form created by our office includes a section for governing body approval. Local governing boards note their approval and submit the application through one of the following three methods:

RESOLUTION/ORDINANCE FOR SUPPLEMENTAL BUDGET and APPROPRIATION (Pursuant to 29-1-109, C.R.S.)

A RESOLUTION ORDINANCE APPROPRIATING ADDITIONAL SUMS OF MONEY TO DEFRAID EXPENSES IN EXCESS OF AMOUNTS BUDGETED FOR THE ROCK CREEK MESA WATER DISTRICT, COLORADO 2020 ARE AS FOLLOWS:

WHEREAS, in August of 2020, the District began experiencing drought conditions in our area. The amount remaining in the well and 5 reservoirs were not enough to provide water to its residents through 2020. The District hired a trucking company to haul water and contracted with Widefield Water and Sanitation Department to purchase water beginning on October 12, 2020. The District had to raise the water rates from \$21.10/1,000 gallons to \$37.77/1,000 gallons until precipitation begins to bring the well back and by spring to begin run off to the reservoirs. We also renewed our loan with the bank, in the amount of \$30,000 to help offset the cost as the district bills to their residents in arrears. The District also borrowed from our COLOTRUST reserve account in the amount of \$60,000.00 to help with the cost of hauling and the purchasing of water.

Therefore, our original budget for 2020, income and expenses, changed drastically with the additional income from our reserves, \$60,000.00 and an additional \$16.67/1,000 gallons charged to our residents.

NOW, THEREFORE, BE IT RESOLVED/ORDAINED BY THE BOARD OF DIRECTORS OF THE ROCK CREEK MESA WATER DISTRICT, COLORADO;

Section 1. That the 2020 appropriation for the **REVENUE** fund is hereby increased from \$270,089 to \$380,899 for the following purpose: to amend our previous 2020 budget revenue/income.
