WHEREAS, the **Board of Directors** of the **Frenchman GWMD** wishes to claim exemption from the audit requirements of Section 29-1-603, C.R.S.; and



WHEREAS, neither revenue nor expenditures for the **Frenchman GWMD** exceeded \$100,000 for Fiscal Year 2020; and
