RESOLUTION FOR EXEMPTION FROM AUDIT
(Pursuant to Section 29-1-604, C.R.S.)

A RESOLUTION APPROVING AN EXEMPTION FROM AUDIT FOR FISCAL YEAR 2022 FOR THE CHEYENNE CREEK METROPOLITAN PARK AND WATER DISTRICT, STATE OF COLORADO

WHEREAS, the Board of Directors of Cheyenne Creek Metropolitan Park and Water District wishes to claim exemption from the audit requirements of Section 29-1-603, C.R.S.; and

WHEREAS, Section 29-1-604, C.R.S. states that any local government where neither revenues nor expenditures exceed seven hundred and fifty thousand dollars may, with the approval of the State Auditor, be exempt from the provision of Section 29-1-603. C.R.S.; and

WHEREAS, neither revenue nor expenditures for Cheyenne Creek Metropolitan Park and Water District exceeded \$100,000 for Fiscal Year 2022; and

WHEREAS, an application has been prepared by Connie Goodwin, a person skilled in governmental accounting; and

WHEREAS, said application for exemption from audit has been completed in accordance with regulations issued by the State Auditor.


NOW THEREFORE, be it resolved by the Board of Directors of the Cheyenne Creek Metropolitan Park and Water District that the application for exemption from audit for Cheyenne Creek Metropolitan Park and Water District for the Fiscal Year ended 2022, has been presented with actual costs and revenue for January through November and estimated costs and revenue for December. This application has been personally reviewed and is hereby approved by a majority of the Board of Directors of the Cheyenne Creek Metropolitan Park and Water District. Those members of the Board of Directors have signified their approval by signing below; and authorize Ms. Goodwin to make minor adjustments to reflect the actual December revenues and expenses. This resolution shall be attached to,
