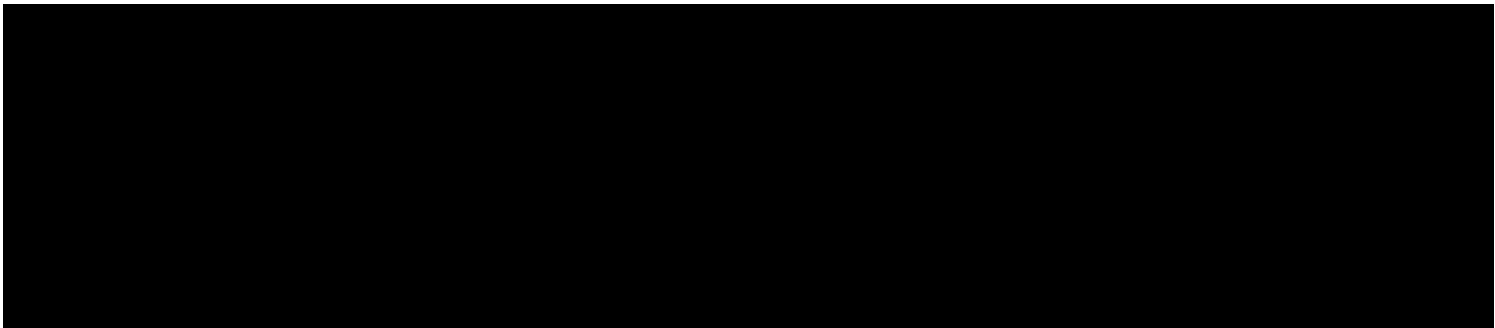

Policy - Requirements
