Policy - Requirements

The Office of the State Auditor Local Government Audit Division may accept an electronic submission of an application for exemption from audit that includes governing board signatures obtained through a program such as DocuSign or Echosign. Required elements and safeguards are as follows:

- The preparer of the application is responsible for obtaining board signatures that comply with the requirement in Section 29-1-604 (3), C.R.S., that states the application shall be personally reviewed, approved, and signed by a majority of the members of the governing body.
- The application must be accompanied by the signature history document created by the electronic signature software. The signature history document must show when the document was created and when the document was emailed to the various parties, and include the dates the individual board members signed the document. The signature history must also show the individuals' email addresses and IP address.
- Office of the State Auditor staff will not coordinate obtaining signatures.

The application for exemption from audit form created by our office includes a section for governing body approval. Local governing boards note their approval and submit the application through one of the following three methods:

- 1) Submit the application in hard copy via the US Mail including original signatures.
- 2) Submit the application electronically via email and either,
 - a. Include a copy of an adopted resolution that documents formal approval by the Board, **or**
 - b. Include electronic signatures obtained through a software program such as DocuSign or Echosign in accordance with the requirements noted above.

RESOLUTION/ORDINANCE FOR EXEMPTION FROM AUDIT

(Pursuant to 29-1-604, C.R.S.)

A RESOLUTION/AN ORDINANCE APPROVING AN EXEMPTION FROM AUDIT FOR FISCAL YEAR 2022 FOR THE CARMEL DRAINAGE DISTRICT, ALAMOSA, COLORADO, FOR THE CALENDAR YEAR BEGINNING ON THE FIRST DAY OF JANUARY, 2022, AND ENDING ON THE LAST DAY OF DECEMBER, 2022.

WHEREAS, the board of Directors of The Carmel Drainage District wishes to claim exemption from the audit requirements of Section 29-1-603, C.R.S. and

WHEREAS, Section 29-1-604, C.R.S. state that any local government where neither revenues for expenditures exceeds seven hundred and fifty thousand dollars may, with the approval of the State Auditor, be exempt from the provisions of Section 29-1-603.

WHEREAS, neither revenue or expenditures for The Carmel Drainage District exceeded \$100,000 for Fiscal Year 2022.

WHEREAS, an application for exemption from auditor for The Carmel Drainage District has been prepared by Wall, Smith, Bateman and Associates, a company skilled in government accounting

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS of the CARMEL DRAINAGE DISTRICT, ALAMOSA, COLORADO:

Section 1. That the 2022 exemption from audit as submitted, amended, and summarized by fund, hereby is approved and adopted as the budget of The Carmel Drainage District for the year stated above.

Section 2. That the 2022 exemption from audit hereby is approved and adopted shall be signed by and made a part of the public records of the Alamosa County and Conejos County.
