NOW THEREFORE, be it resolved by the Board of Trustees of the Penrose Community Library District that the application for exemption from audit for the Penrose Community Library District for the fiscal year ended December 31, 2023, has been personally reviewed and is hereby approved by a majority of the Board of Trustees of the Penrose Community Library District; and those members of the Penrose Community Library District have signified their approval by signing below; and that this resolution shall be attached to, and shall become part of the application for exemption from audit of the Penrose Community Library District for the fiscal year ended December 31, 2023.
