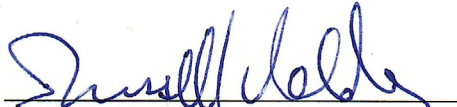
WHEREAS, neither revenues nor expenditures for Northwest Conejos Fire Protection District exceeded \$500,000 for fiscal year 2024; and
