The Office of the State Auditor Local Government Audit Division may accept an electronic submission of an application for exemption from audit that includes governing board signatures obtained through a program such as DocuSign or Echosign. Required elements and safeguards are as follows:

WHEREAS, neither revenues nor expenditures for the Bookcliff Conservation District exceeded \$750,000.00 for Fiscal Year 2022; and


WHEREAS, an application for exemption from audit for the Bookcliff Conservation District has been prepared by Tiffany Rudow, a person skilled in governmental accounting and;
