Um, I was sharing with an individual earlier today and I am just about done but I was sharing with individual earlier today that while I was not a member of the board of Public Works and Safety in the years of 1999 to 2003 I had a lot of dealings with the Board of Public Works and Safety as the deputy chief. In fact, uh we tried to make sure that whatever we did in law enforcement was transparent and brought to the board with transparency. Uh, I don't see that this board has operated outside since that time when I followed the Board of Public Works. I don't see that this board has operated outside of the scope that any other board has operated out of. In fact, I think in some cases we have asked more questions and brought more transparency to government. So, I want to thank this board for your work and your efforts in continuing to serve citizens well and we will continue to serve citizens well regardless of what happens with this ordinance and its passing. Thank you. Those are just Alex Huskey's comments.
