Assistant Chief Eckstein: We post it inside the fire house um we always do the fill in from within the stations.

Linda Wilk: And then if you don't have a candidate the next step would be outside of?

Assistant Chief Eckstein: No, we have to appoint some body to that position then.

Linda Wilk: Just wanting to make, clarify that.

Alex Huskey: So when you post does it go to all the stations or just the one?

Assistant Chief Eckstein: All the stations.
