<u>General Ordinance 16-2025-Issuance of Taxable Economic Revenue Bonds- 2nd reading and public hearing</u>
An ordinance authorizing the issuance of one or more series of taxable economic development revenue bonds, series 2025. Speaking: Chris Greisl, Barnes & Thornburg LLP

Executive summary: Vita Investment Holdings, LLC, Jones Heritage, LLC, and Built-Marion, LLC have submitted a proposal to redevelop the Jones middle school into approximately eighty (80) apartment units, (ii) construct approximately fifty-six (56) cottage units, and (iii) develop and construct approximately thirty-six (36) flex-industrial units and one hundred forty-six (146) self-storage units, all on the Project Site. The Company expects that its total investment in the Project will be approximately Forty Million and no/100 Dollars \$40,000,000. As a result, the City has agreed to provide certain incentives to assist the Company in the construction of the project pursuant to certain Project Agreements. The City proposes to issue two or more series of Economic Development Revenue Bonds in the aggregate principal amount of \$7,500,000.

- Ray Dosh from the Marion Municipal Airport requests an additional appropriation of \$83,147.86 for the replacement of underground fuel storage tanks.
- Ray Dosh discusses the challenges of securing funding from other government entities, including Gas City and the county.
- Council members express concerns about the financial impact on the city and the potential loss of funding if the project is not completed.

- Deborah Cain, Center Township Trustee, requests \$300,000 for the maintenance and revitalization of the Estates of Serenity Cemetery.
- Council members discuss the long-term sustainability of the funding and the potential for a cemetery tax levy.

Public hearing

- Karen Creech asked what plan B is. Karen Creech stated this should be privately funded not city funded. Against it for now.
- Ruthann Sumpter expressed this cemetery is full of history. It is an eyesore and an embarrassment to the community. In favor of the request.
- Angela Mast stated there has been a lack of clean-up effort in the last few years. There have been a lot of improvements in the last few weeks. In favor of this.

• Catherine Bright explained Deb Cain is doing all that she can. It looks great but she cannot do it alone. She is in favor of this appropriation.

Public hearing closed.

- Brian Cowgill stated he volunteered to help in the main office of the cemetery. They need the funds that were promised. In favor.
- Mike Cline agrees there have been massive improvements, but by statute the trustee is responsible for a tax levy. Not in favor.
- Gary Fordyce expresses he feels the city should not do this due to other big needs for other departments. The city pays for two inmate work crews. We should use them instead. Not in favor.
- Jim Brunner states it looks so much better, and it deserves our best.
- Nick McKinley states the tax levy is not an immediate process. This is a one-time request from the Trustee's office. In favor of this appropriation.
- Eric Marshall said there is tremendous energy. There should be a capital campaign to raise the funds so the city should not be responsible for funding this.
- David Cain explains the Trustee's office has been denied the inmate work crews. In favor of this.

- Dana Galt, City Controller, and Parker Bryce from Boyce Cloud introduce the request for \$144,555 to upgrade the financial software to a cloud-based system.
- Council members inquire about the cost of expanding the software to other departments and the annual fees associated with the new system.
- Nick McKinley questions if travel expenses are included in the \$144,000 quote.
- Parker Bryce clarifies that travel expenses are for training, not migration, and explains the benefits of in-person training over virtual.
- Parker Bryce mentions the flexibility of training duration based on the controller's office needs.
- Mike Cline inquires about future training costs if other departments join.
- Nick McKinley asks about the contract duration and migration costs.
- Parker Bryce explains the migration fee includes moving the current system to the cloud.
- Nick McKinley questions the scope of the \$50,000 migration fee.
- Parker Bryce details the process of moving data to the cloud and the timeline for larger cities like Marion.
- Nick McKinley asks about data retention if the contract is canceled.
- Parker Bryce confirms that the city owns its data.
- Parker Bryce estimates a six-month timeline for larger cities like Marion.
- Andy Whitton questions the cost savings from the new software.
- Parker Bryce explains the benefits of enhanced cybersecurity and reduced server costs.
- Erika Devine asks about the data migration history and future data access.

- Parker Bryce clarifies that the new system will hold all data, while older data will be accessible through queries.
- Nick McKinley asks about the efficiency of the controller's department.
- Dana Gault explains the benefits of automation and improved efficiency.
- Parker Bryce discusses the integration of other departments and the benefits of cloud-based systems.
- Mike Cline inquires about the impact of not adopting the new system.
- Eric Marshall asks about the need for hardware assessments and costs.
- Parker Bryce confirms that the new system requires only an internet connection and a browser.
- Gary Fordyce questions the integration with existing cybersecurity investments.
- Parker Bryce explains that the new system will reduce the burden on the city's cybersecurity firm.
