## UNFINISHED BUSINESS

### General Ordinance 25-2025- Rezoning ordinance, 2<sup>nd</sup> reading and public hearing

An ordinance of the common council of the city of Marion amending Marion City Code Chapter §153 (Zoning Ordinance). Speaking: Mayor Ronald Morrell

**Executive summary:** At the regular monthly meeting of the City of Marion Advisory Plan Commission on September 23, 2025, the main agenda item was a public hearing for the rezoning of 800 East Third Street from I-1 Light Industry to GB-General Business for a new restaurant and event center. The proposal aligns with the comprehensive plan's criteria and received a positive staff recommendation. The motion to approve the rezoning was made, seconded, and passed unanimously and subsequently passed on to the City Council.

### General Ordinance 27-2025- Bonds for Marion Utilities 2<sup>nd</sup> reading and public hearing

An ordinance approving bonds for Marion Utilities.

**Executive summary:** An ordinance concerning the construction of additions and improvements to the sewage works of the City of Marion, Indiana, the issuance of revenue bonds to provide the cost thereof, the collection, segregation and distribution of the revenues of said sewage works, the safeguarding of the interests of the owners of said revenue bonds, other matters connected therewith, including the issuance of notes in anticipation of bonds, and repealing ordinances inconsistent herewith.

## **NEW BUSINESS**

### **Additional Appropriation 15-2025- Additional Appropriation for Transportation**

An additional appropriation for the City of Marion Transportation Department.

**Executive summary:** We need to address an issue with the transportation budget for account 2418. The 2022 audit report required that transportation have its own dedicated fund. However, by late 2023, the 2024 budget had already been completed and submitted to the council. As a result, no city funds were appropriated for the matching portion in either 2023 or 2024. To rectify this oversight, we are requesting an additional appropriation to correct these past years. The total city portion was \$638,658.00.

### **Additional Appropriation 16-2025- Additional Appropriation for Parks and Recreation**

An additional appropriation for salaries for the park's security officers. Speaking: Rose Cadena and the Controller's office

**Executive summary:** This request is for an additional appropriation in the amount of \$27,972.00 to fund three security positions for our city parks. The goal is to enhance the safety and security of both the parks and their visitors. These security staff members will provide coverage for our parks at least 42 hours a week, seven days a week. The salary ordinance for these positions has already been approved.

- These positions are already in the 2026 budget this is just for the remainder of 2025.


