UNFINISHED BUSINESS

General Ordinance 26-2025- Bonds for Parks District- 2nd reading and public hearing

An Ordinance Approving the Issuance of Bonds of the City of Marion Parks District and Related Matters. Speaking: Joe Murphy, Chris Greisl, and a representative from Baker Tilly.

Executive summary: On October 6, 2025, the Park and Recreation Board of the Park District of the City of Marion, Indiana adopted a resolution determining preliminarily to issue special taxing district bonds, in one or more series, in an aggregate principal amount not to exceed Two Million Dollars (\$2,000,000) to finance the construction, acquisition, renovation, installation and equipping of improvements at various parks in the district, including a new Municipal Skatepark and Southside Food Truck Park.

Additional Appropriation 15-2025- Additional Appropriation for Transportation 2ND reading and public hearing An additional appropriation for the City of Marion Transportation Department. Speaking: Controller's Department

Executive summary: We need to address an issue with the transportation budget for account 2418. The 2022 audit report required that transportation has its own dedicated fund. However, by late 2023, the 2024 budget had already been completed and submitted to the council. As a result, no city funds were appropriated for the matching portion in either 2023 or 2024. To rectify this oversight, we are requesting an additional appropriation to correct these past years. The total city portion was \$638,658.00.

Additional Appropriation 16-2025- Additional Appropriation for Parks and Recreation 2nd reading and public hearing

An additional appropriation for salaries for the park's security officers. Speaking: Rose Cadena and the Controller's office

Executive summary: This request is for an additional appropriation in the amount of \$27,972.00 to fund three security positions for our city parks. The goal is to enhance the safety and security of both the parks and their visitors. These security staff members will provide coverage for our parks at least 42 hours a week, seven days a week. The salary ordinance for these positions has already been approved.

NEW BUSINESS

Resolution 15-2025 Lease agreement among the Marion Redevelopment Commission and the Marion Redevelopment Authority

A resolution of the Common Council approving a lease between the Marion Redevelopment Authority and the Marion Redevelopment Commission and addressing matters related thereto. Speaking: Mayor Morrell, Barnes & Thornburg LLP, and Baker Tilly Municipal Advisors.

Executive summary: The Marion Redevelopment Authority is considering the issuance of one or more series of bonds in the maximum principal amount of \$20,000,000, to finance all or any portion of the Ballard Fields Project, the Bridge Project, the Airport Utilities Project, and the Fire Truck Project. The lease provides for the lease by the Redevelopment Authority to the Redevelopment Commission of certain real estate, consisting of all or a portion of Washington Street in the City from 1st Street to 32nd Street. The Redevelopment Commission has conducted a public hearing and approved the form of lease presented for the purpose of paying the principal and interest on the Bonds issues to finance the Projects. The Redevelopment Authority has authorized the issuance of Bonds and approved the form of Lease.

General Ordinance 28-2025- Adding no parking zones 1st reading

An ordinance establishing a no parking zone on the east side of Washington Street from 7th Street to 10th Street. Speaking: Administrative/Project manager Mike Graft

Executive summary: With the construction of the walking path and parking bump-outs along the west side of Washington Street from 7th Street to 9th Street, it reduces the overall travel lane width of Washington Street. This reduction prompted an engineering recommendation to create a 'No Parking' section on the east side of Washington Street to enhance traffic movement and overall public safety from 7th Street all the way to 10th Street.

General Ordinance 29-2025- Rezoning Ordinance 1st reading

An ordinance of the common council of the city of Marion amending Marion City Code Chapter §153 (Zoning Ordinance). Speaking: Mike Graft or Bryan Stumps

Executive summary: At the regular monthly meeting of the City of Marion Advisory Plan Commission on October 28, 2025, the main agenda item was a public hearing for the rezoning of lots 78 and 79 of Gray Dodd's 1st Addition, being a part of the Family Express development at 301 S. Baldwin Ave., from R4-Medium Density Single & Multi-Family Residential to GB-General Business, which is the same zoning as the remainder of the property in this development. The proposal aligns with the comprehensive plan's criteria and received a positive staff recommendation. The motion to approve the rezoning was made, seconded, and passed unanimously and subsequently passed on to the City Council.

Resolution 15-2025- Lease Agreement for Marion Redevelopment Commission and Marion Redevelopment Authority

A resolution of the Common Council approving a lease between the Marion Redevelopment Authority and the Marion Redevelopment Commission and addressing matters related thereto.

- Joe Murphy explains the project, which involves issuing \$20 million in new money to fund four major projects, adding to the two projects already completed.
- Joe Murphy discusses the lease financing structure due to Indiana's constitutional debt limit, which restricts cities to 2% of their assessed value in general obligation debt.

• The redevelopment authority will issue bonds up to \$20 million, with proceeds flowing back to the city to perform the four projects.

- The ordinance aims to enhance traffic movement and public safety.
- Council members discuss the impact on adjoining property owners and the church, with no significant issues reported.

- Brian Stumpf from HWC and Patrick Lyp from Family Express provide details about the project, including its alignment with the comprehensive plan and the positive recommendation from the Planning Commission.
- Patrick Lyp explains the \$9 million investment and the company's commitment to the Marion community.
- Council members discuss concerns about traffic safety in the alleyway and the agreement to maintain it as a right of way.
