## WOL

## Community Foundation

Rose stated the WOL received a grant from the Community Foundation for \$2,644.00 for a new automated display.

## Doug Darga

Rose stated Doug Darga is no longer with the Parks Dept. Julie Fauser and Julia Glessner will continue to take care of the Gardens area. The Parks Dept is currently taking applications for 2 positions.

## Old Concessions

John Valasquez from the Audubon Club stated they want to make sure that since Belinda is no longer hear that we are still interested in the project for the old concession stand being used as a conservatory. There have already been some donations deposited in the Parks Dept Non reverting approx $\$ 900-\$ 1000$ dollars. John wants the Parks Dept to Paint the building. Alan suggested planting trees, etc. to create the habitat before a lot of money is put into the structure to see if it will even work.
