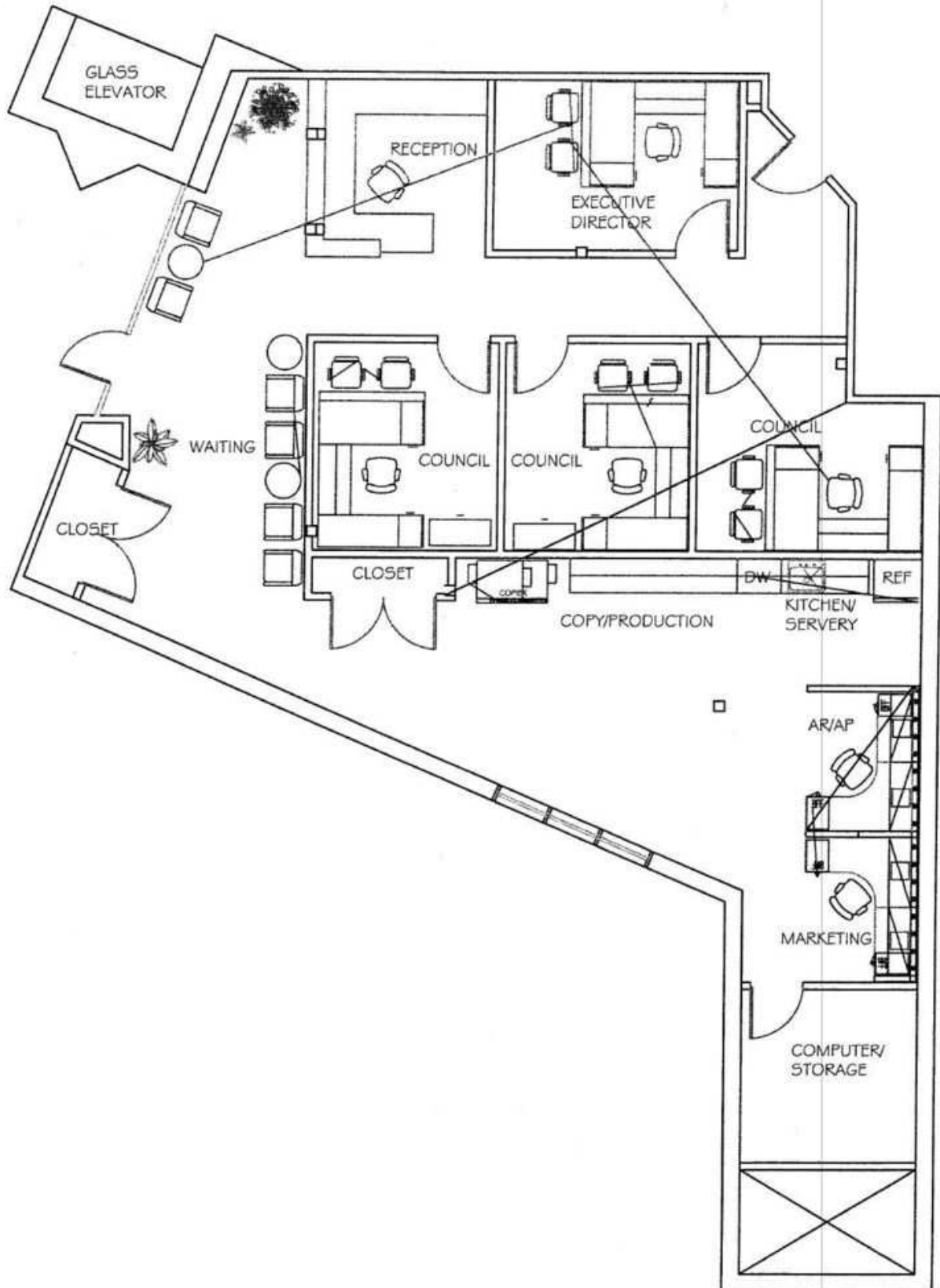

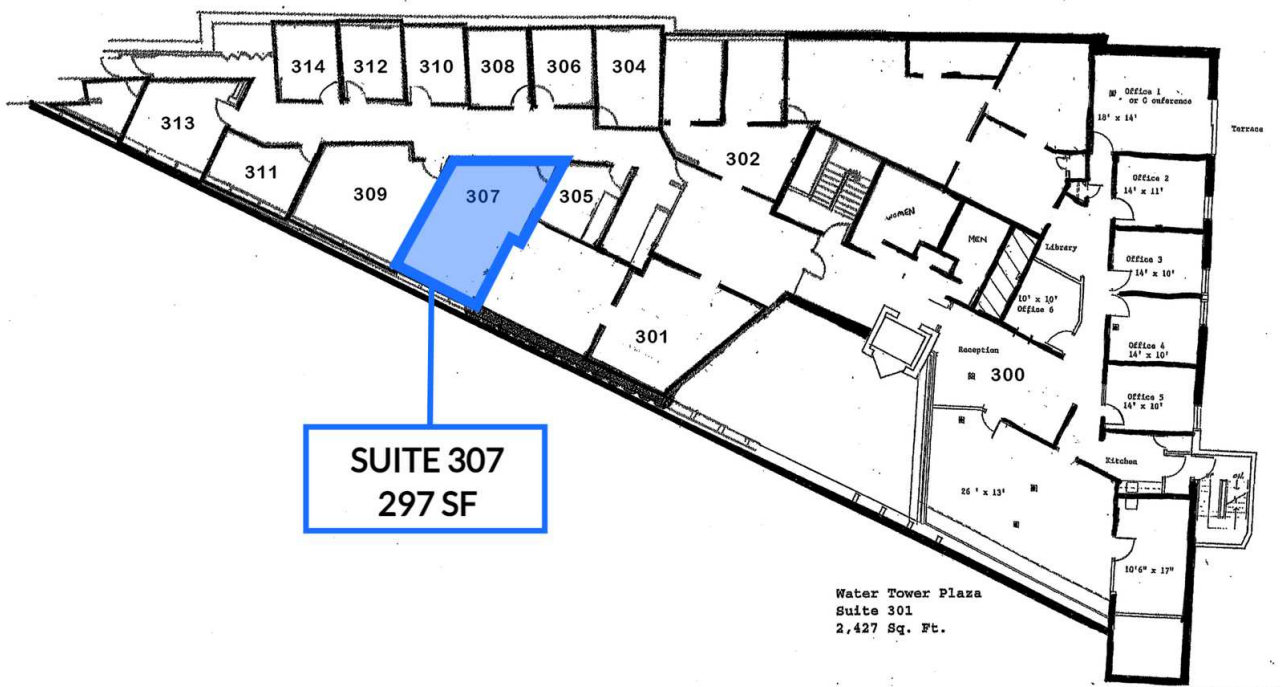
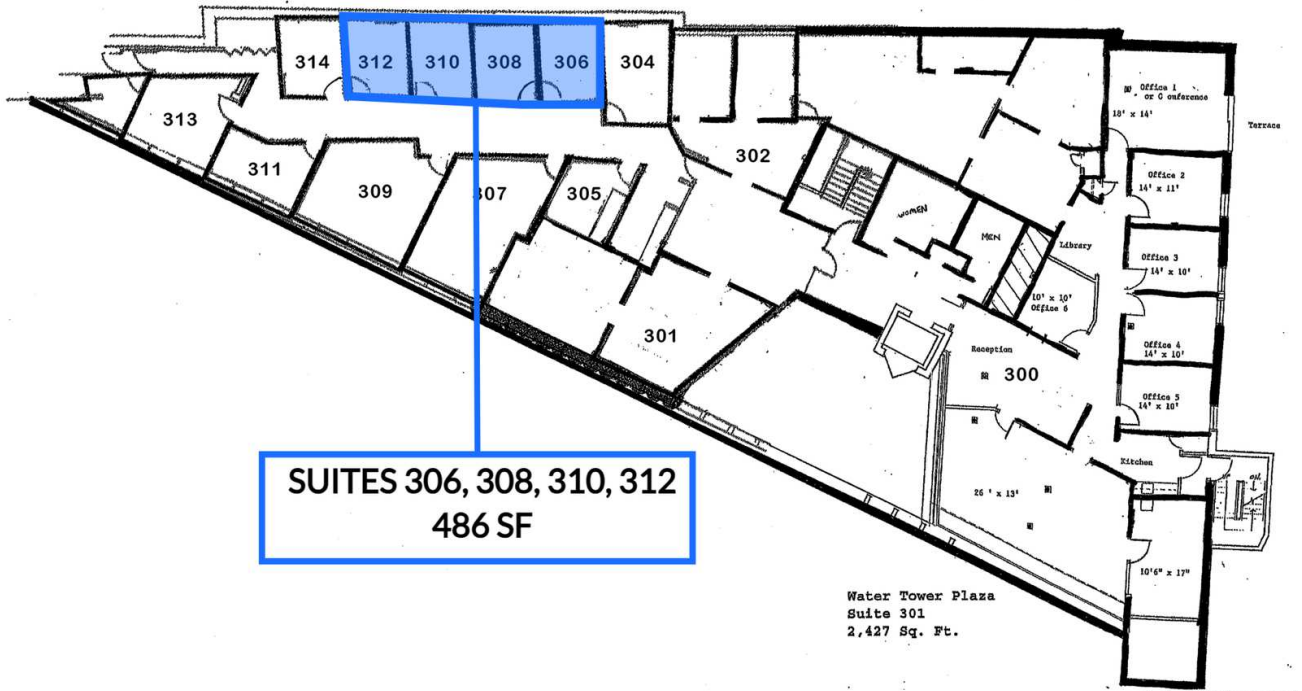

FLOOR PLAN - FIRST FLOOR



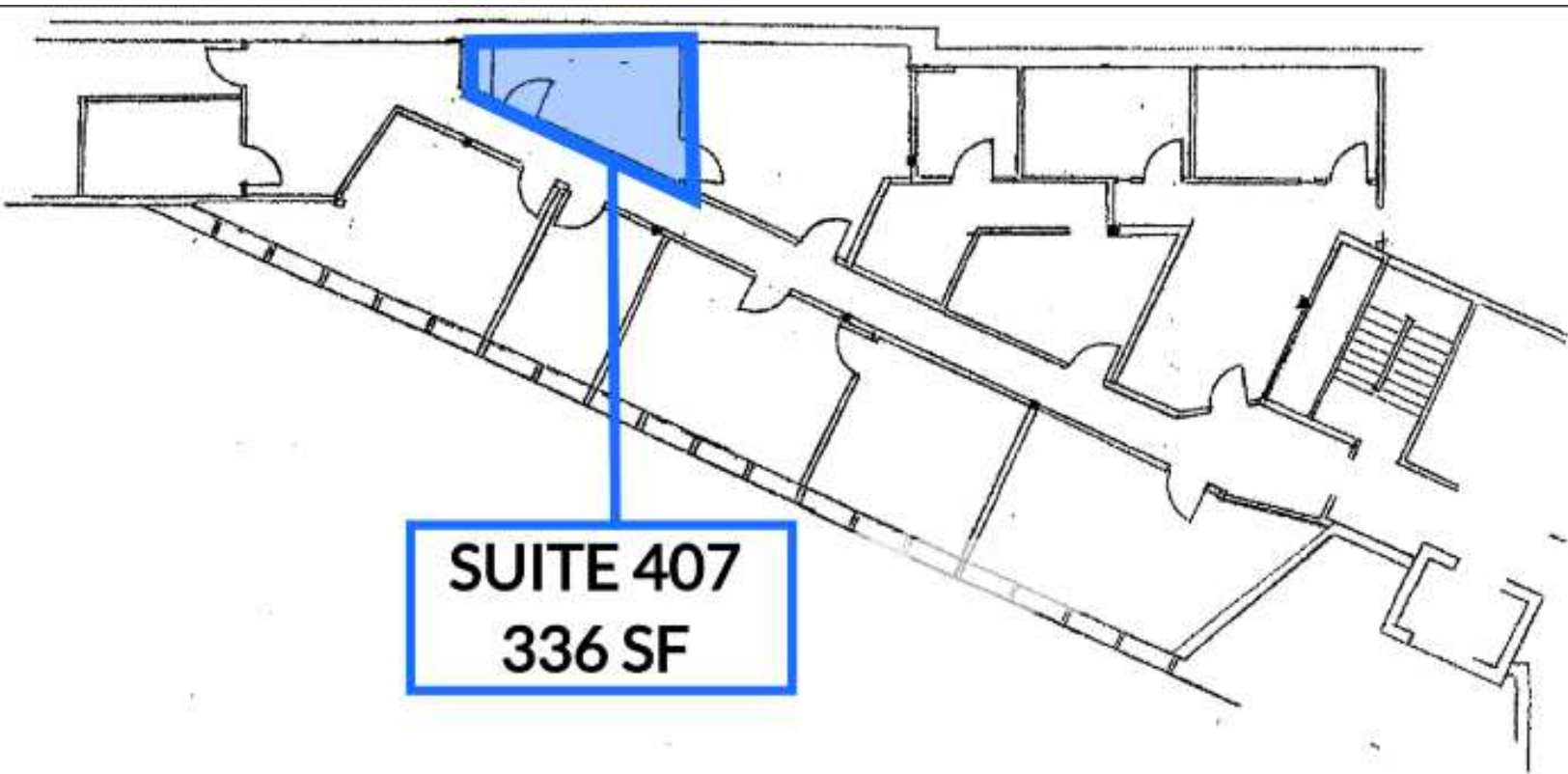

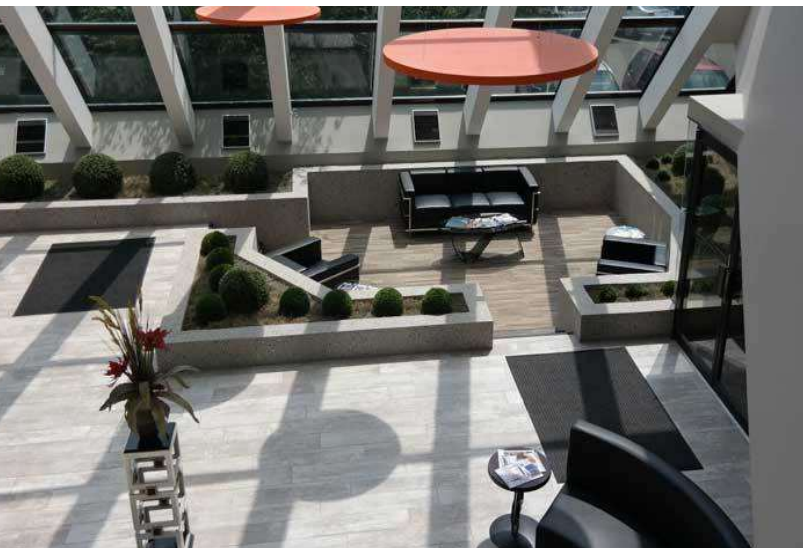

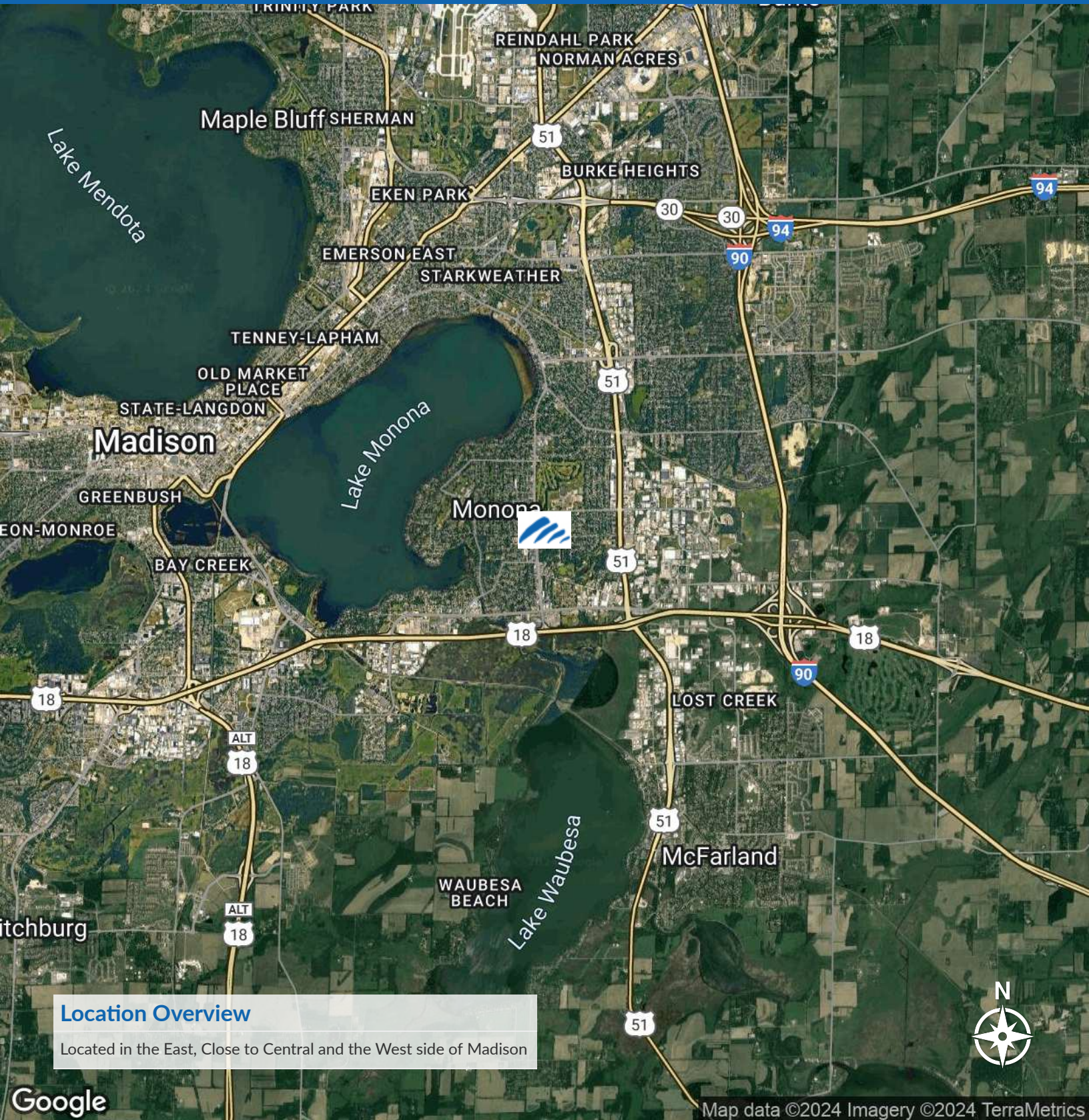

Located in the East, Close to Central and the West side of Madison



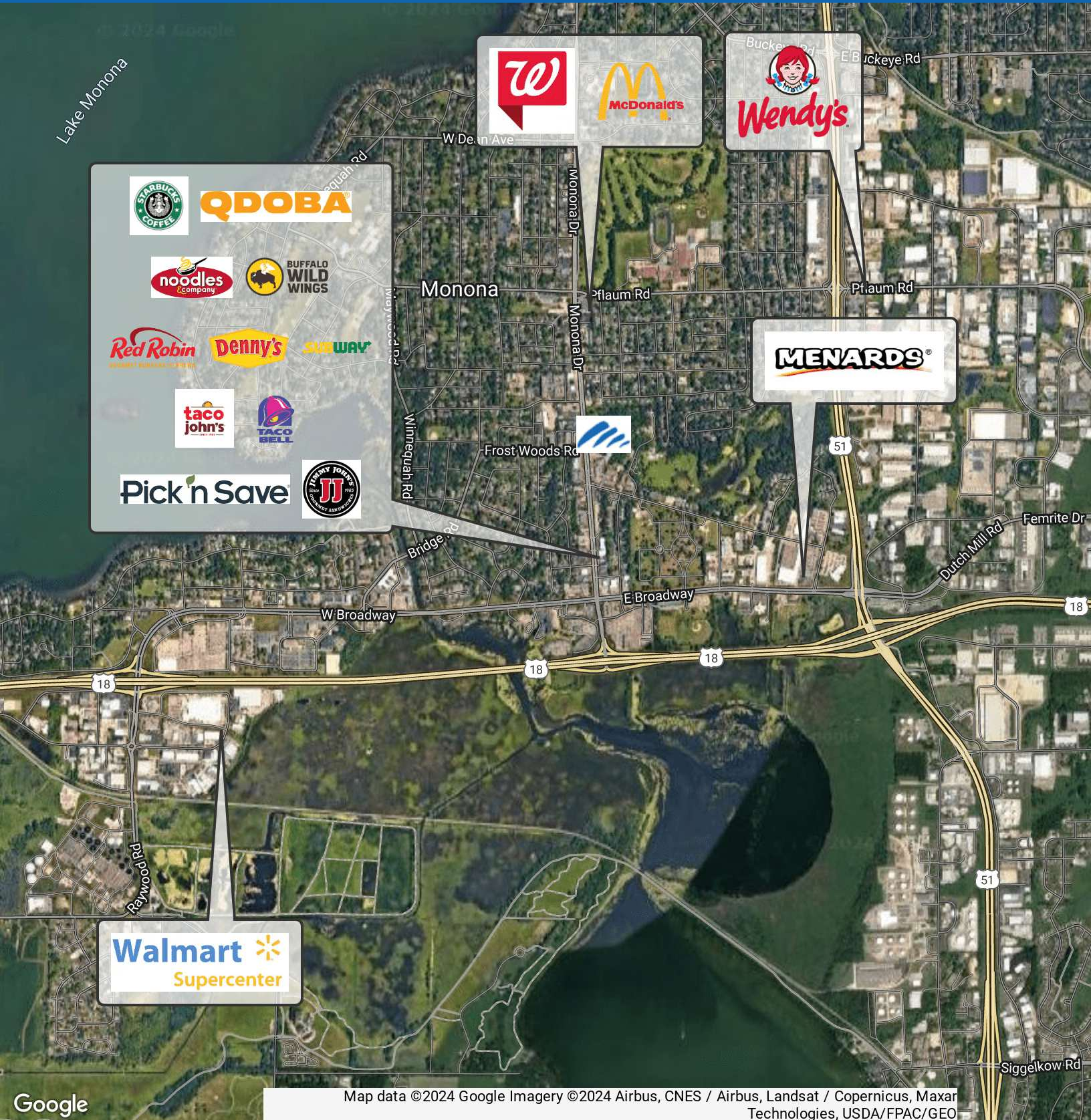

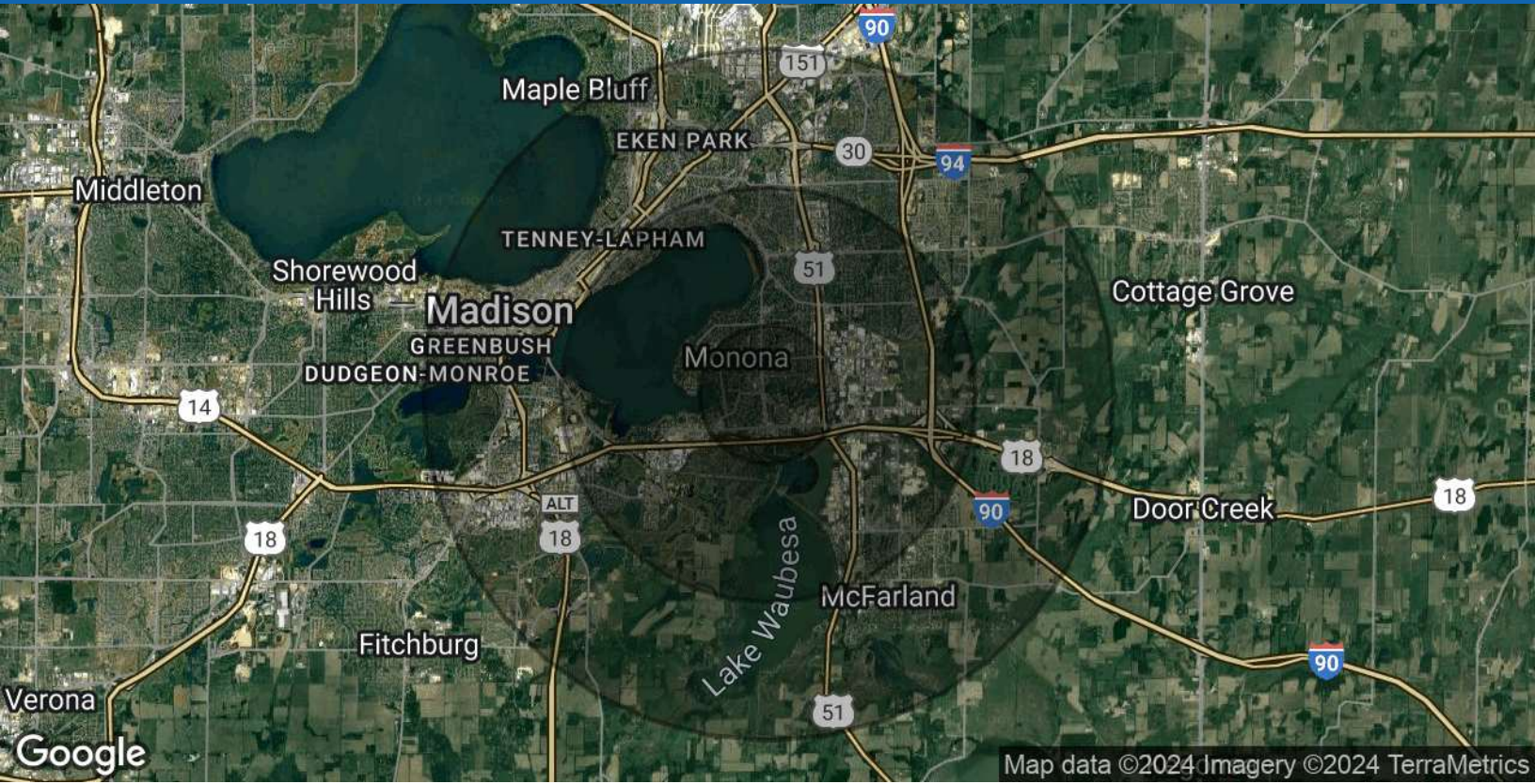
