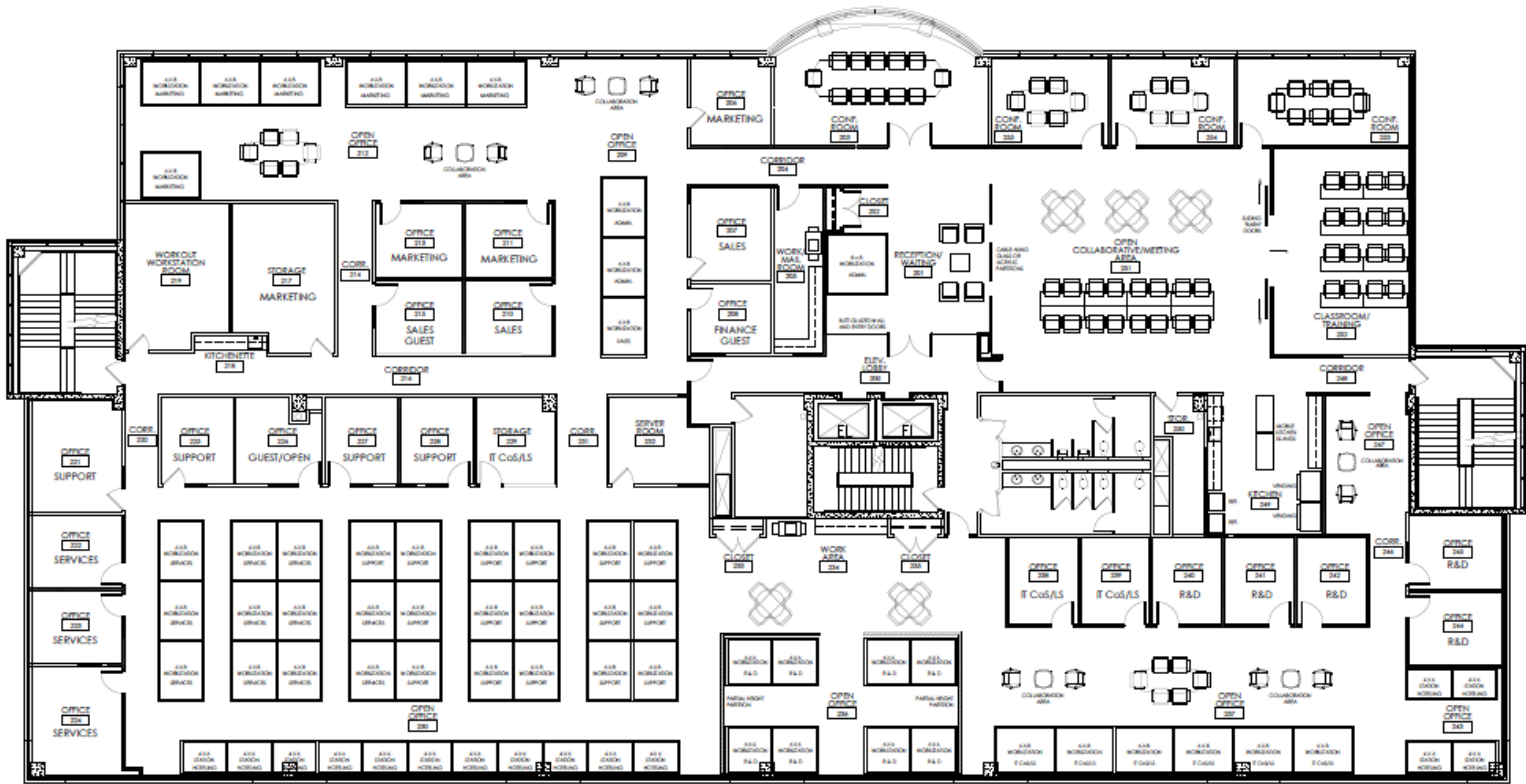

Location Maps



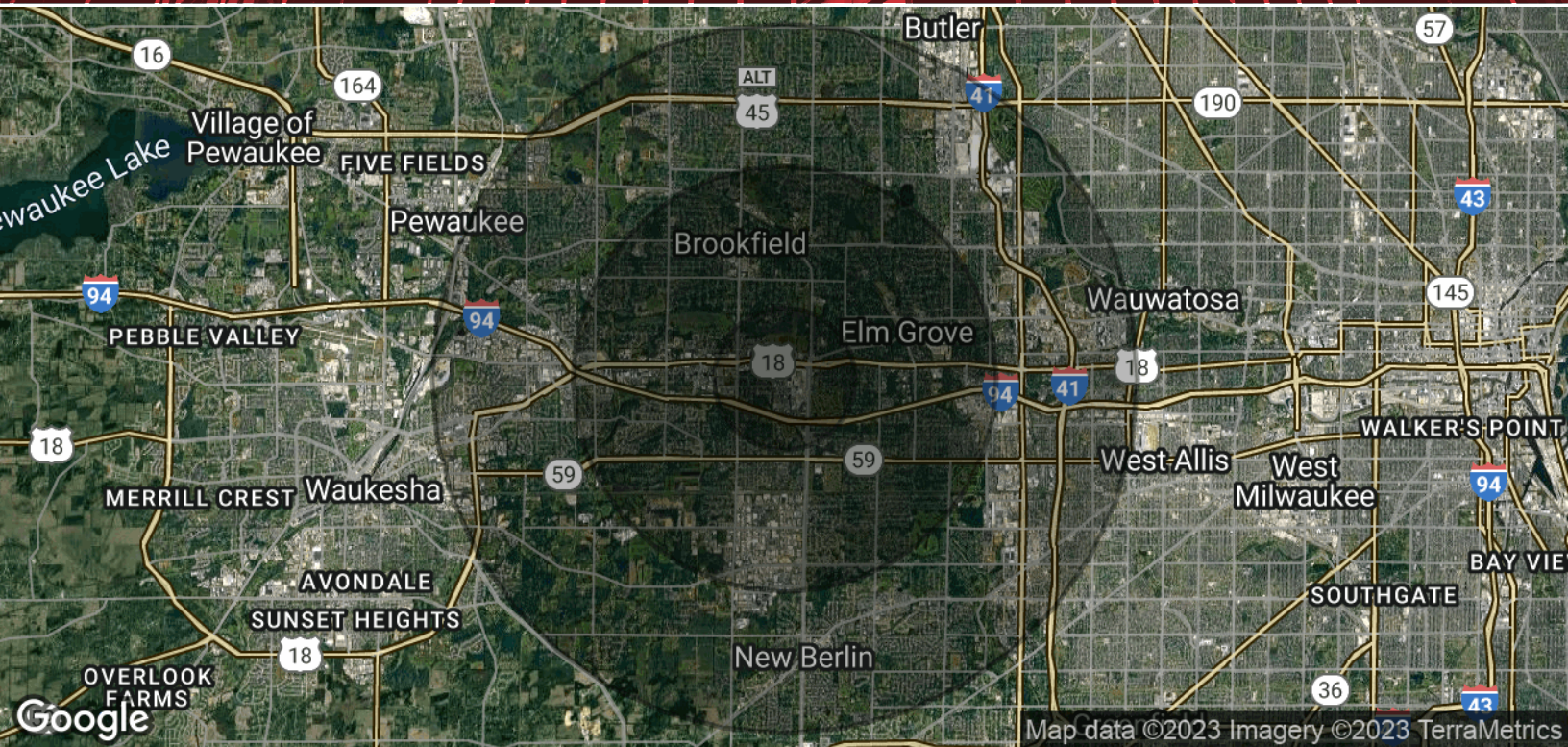
