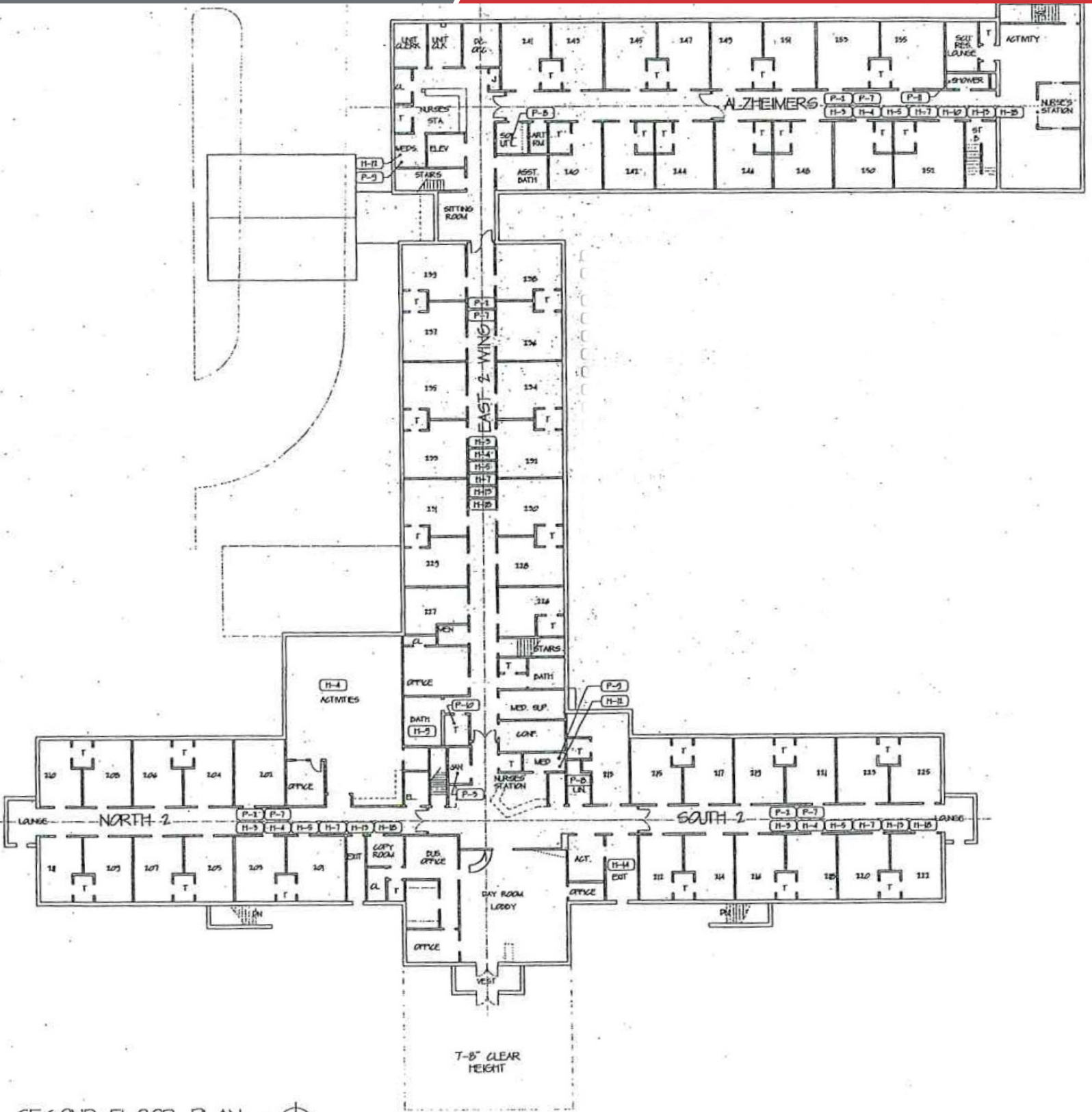

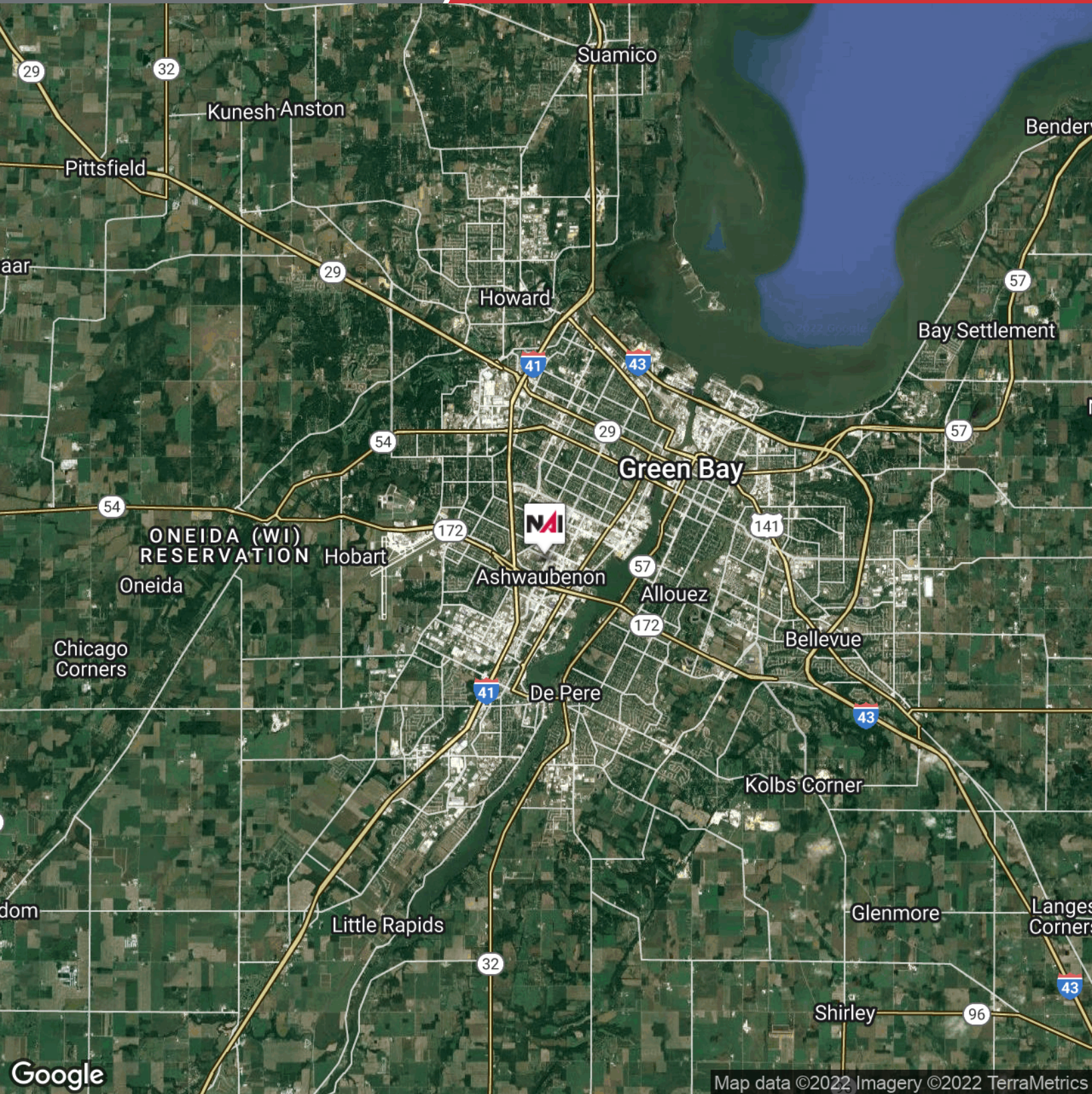


SECOND FLOOR PLAN

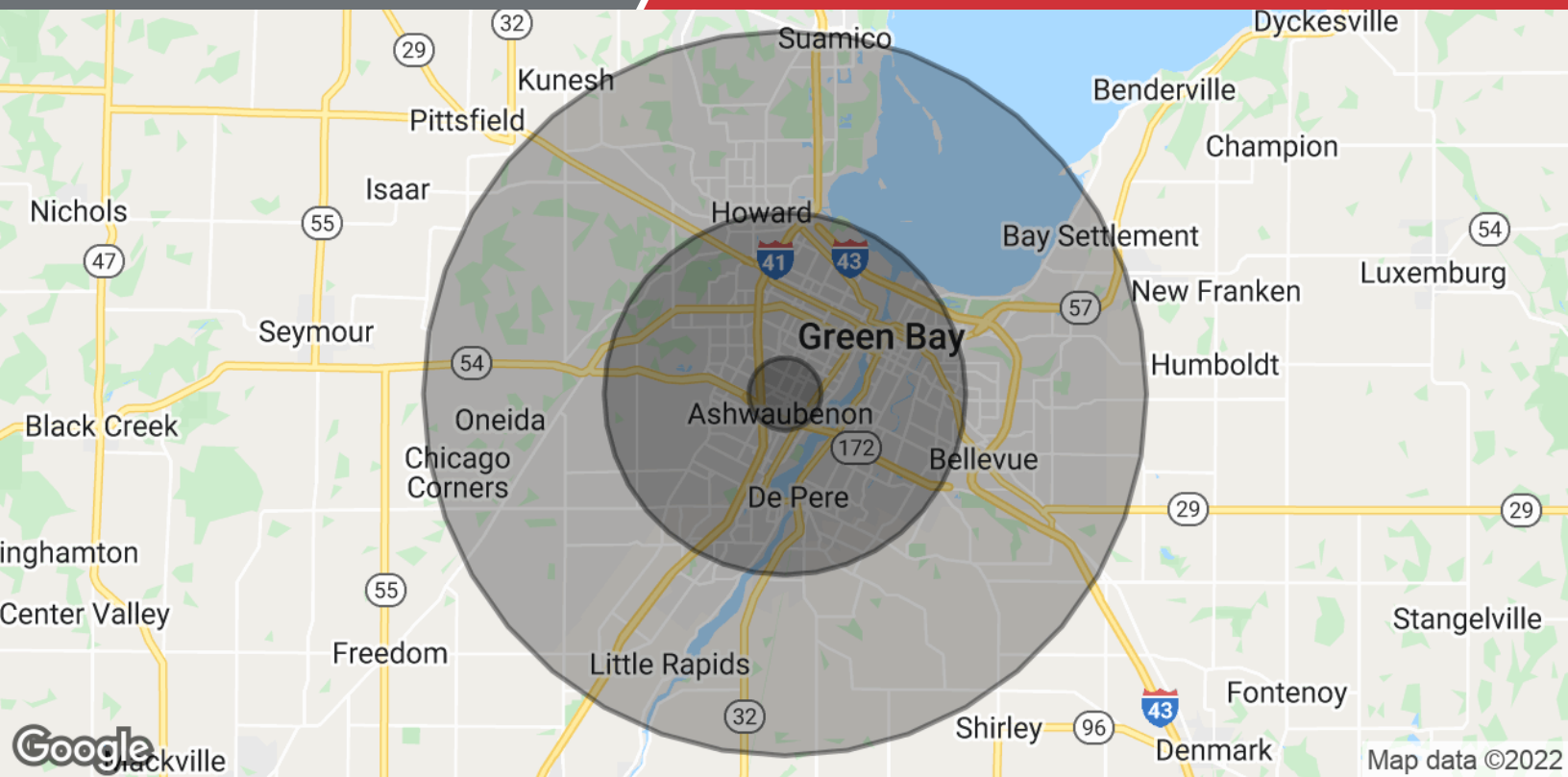
