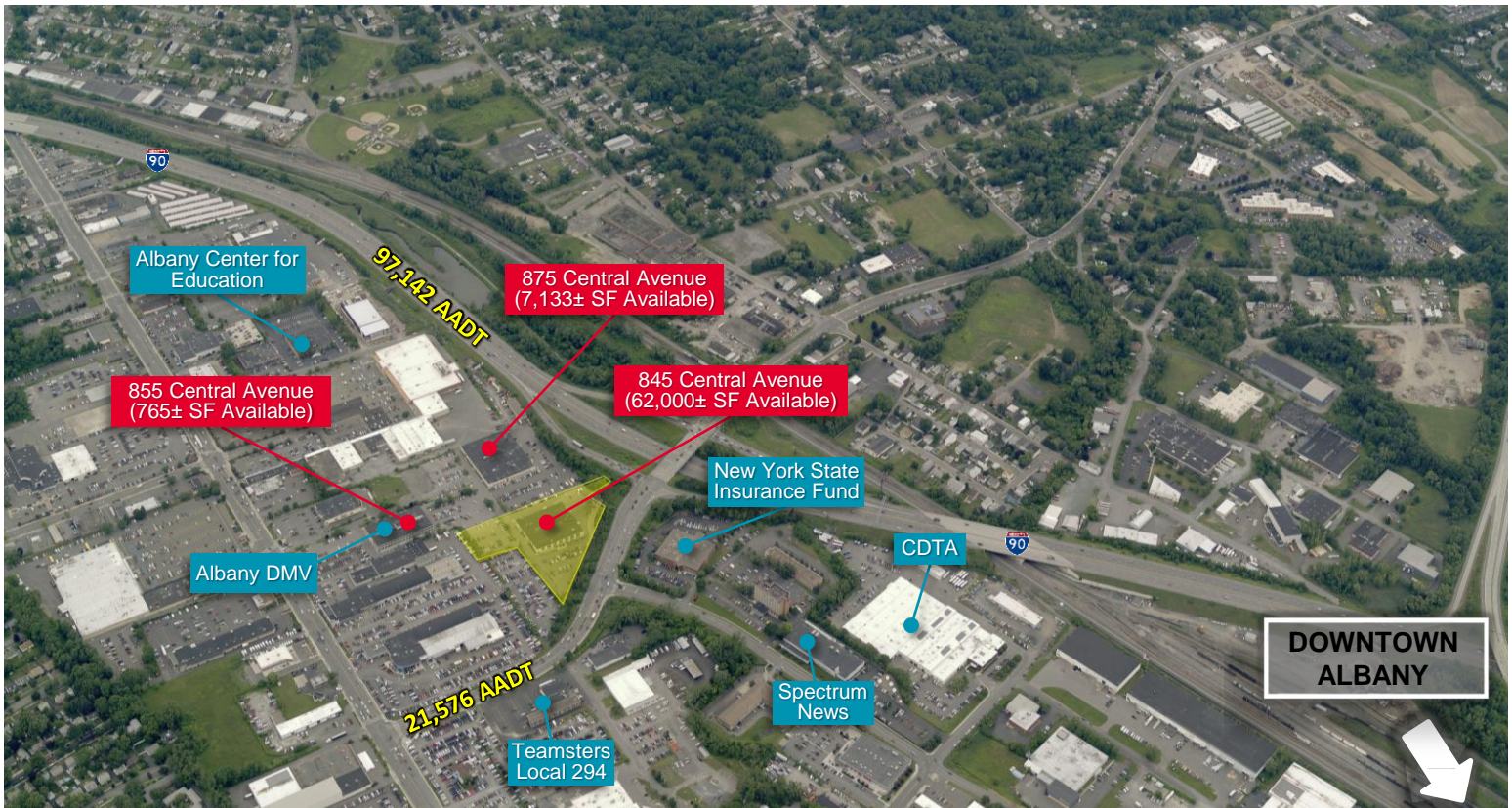
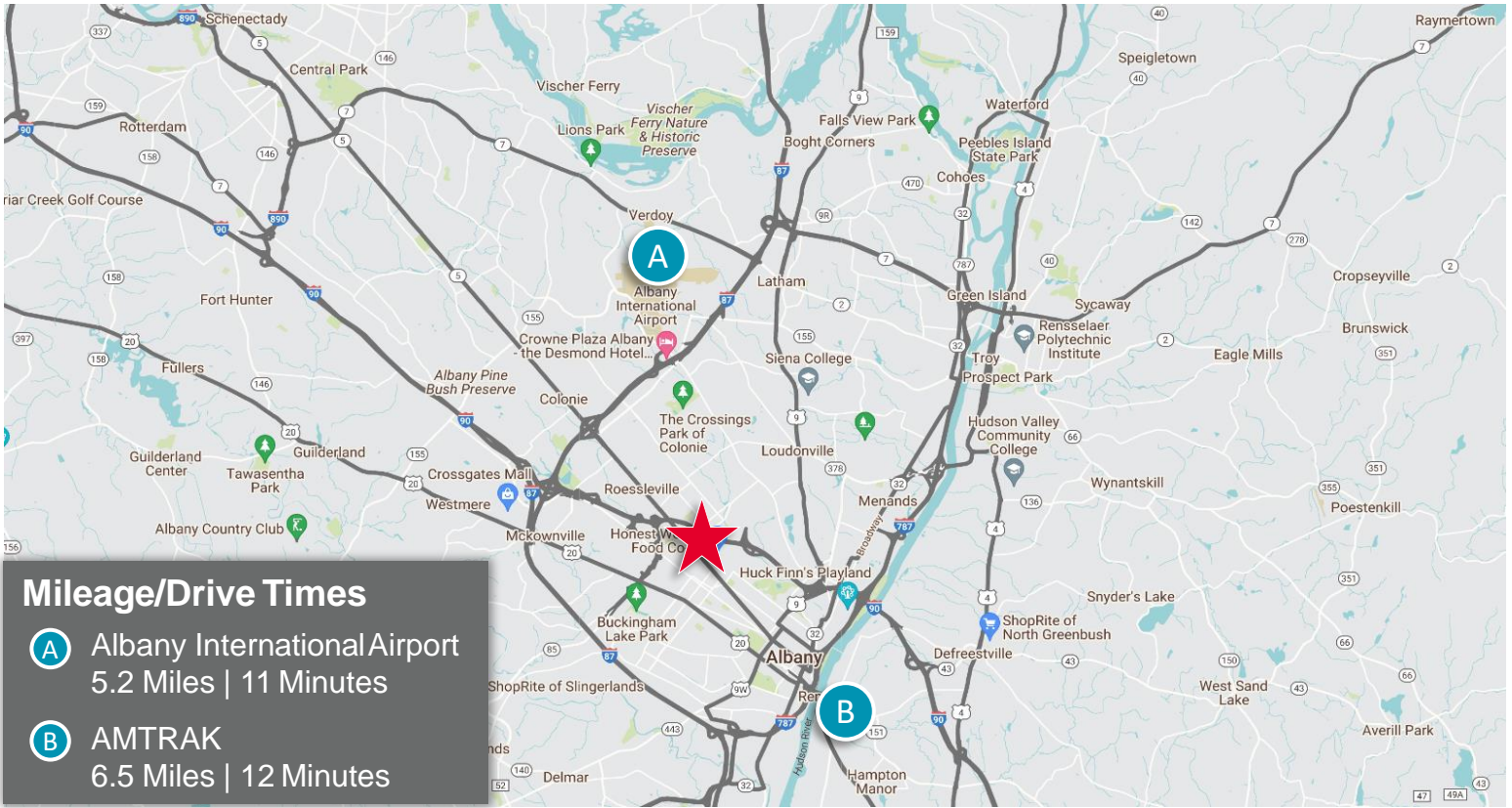

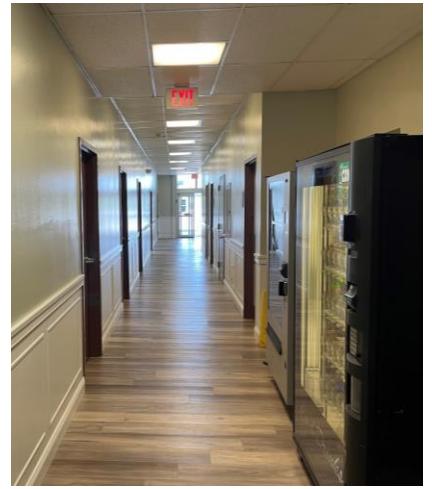
LOCATION MAPS
