


LOCATION OVERVIEW

East Hollywood is a neighborhood in Los Angeles in the central region of Los Angeles County. It contains Little Armenia, Melrose Hill and Thai Town; neighboring communities are Hollywood, Hollywood Hills, Koreatown, Larchmont, Los Feliz, Silver Lake, Westlake and Windsor Square. 









SITE MAP


