Property Overview

The Historic "Cedarburg Mall" is a 3,711 SF office/retail destination located adjacent to the Wirth Building in Historic Downtown Cedarburg.

The Washington Avenue Historic District has experienced a renaissance over the past decade with the addition of approximately 270 luxury multifamily apartment homes (Arrabelle and Fox Run) less than a block from this space. Moreover, the City has added a variety of boutique local and national retailers, including: Brandywine, Real Health & Fitness, Starbucks, Frannie's Market, Bella Lei Salon, Dunkin Go, Bank First, Walgreens, Brunch, and more!

This inline street level retail location on Washington Avenue sees approximately 12,250 vehicles pass by per day and features ample surface lot and street parking. The intersection of Washington Avenue & Western Road boasts approximately 17,900 vehicles per day.

Ownership is motivated to find an end-user that aligns with not only the property, but also the greater Historic Downtown Cedarburg District.
