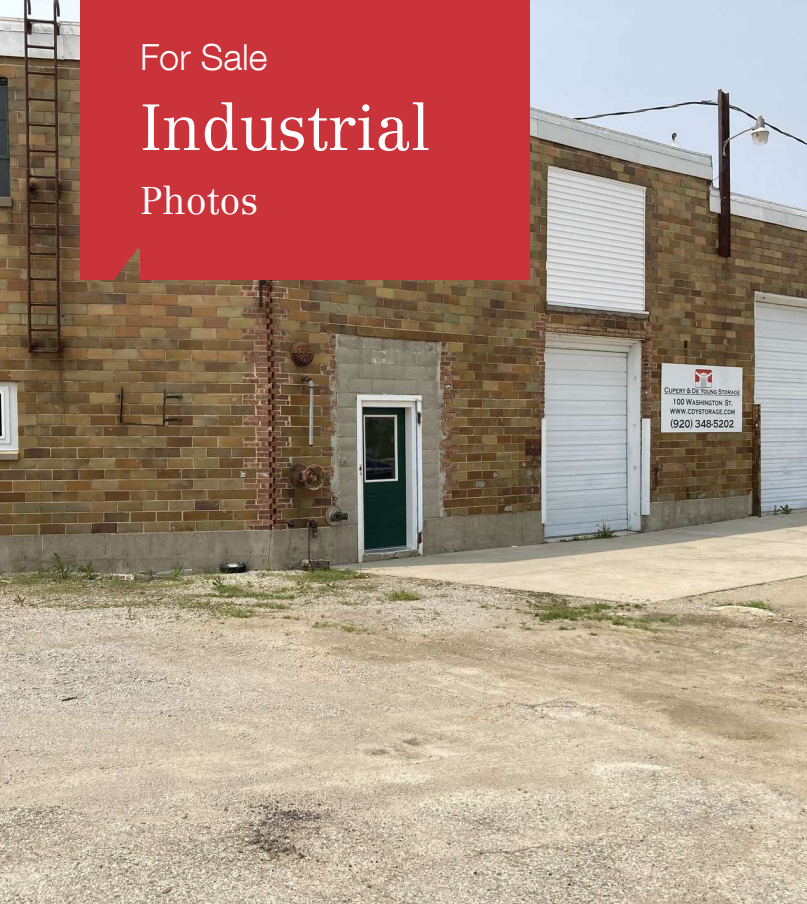

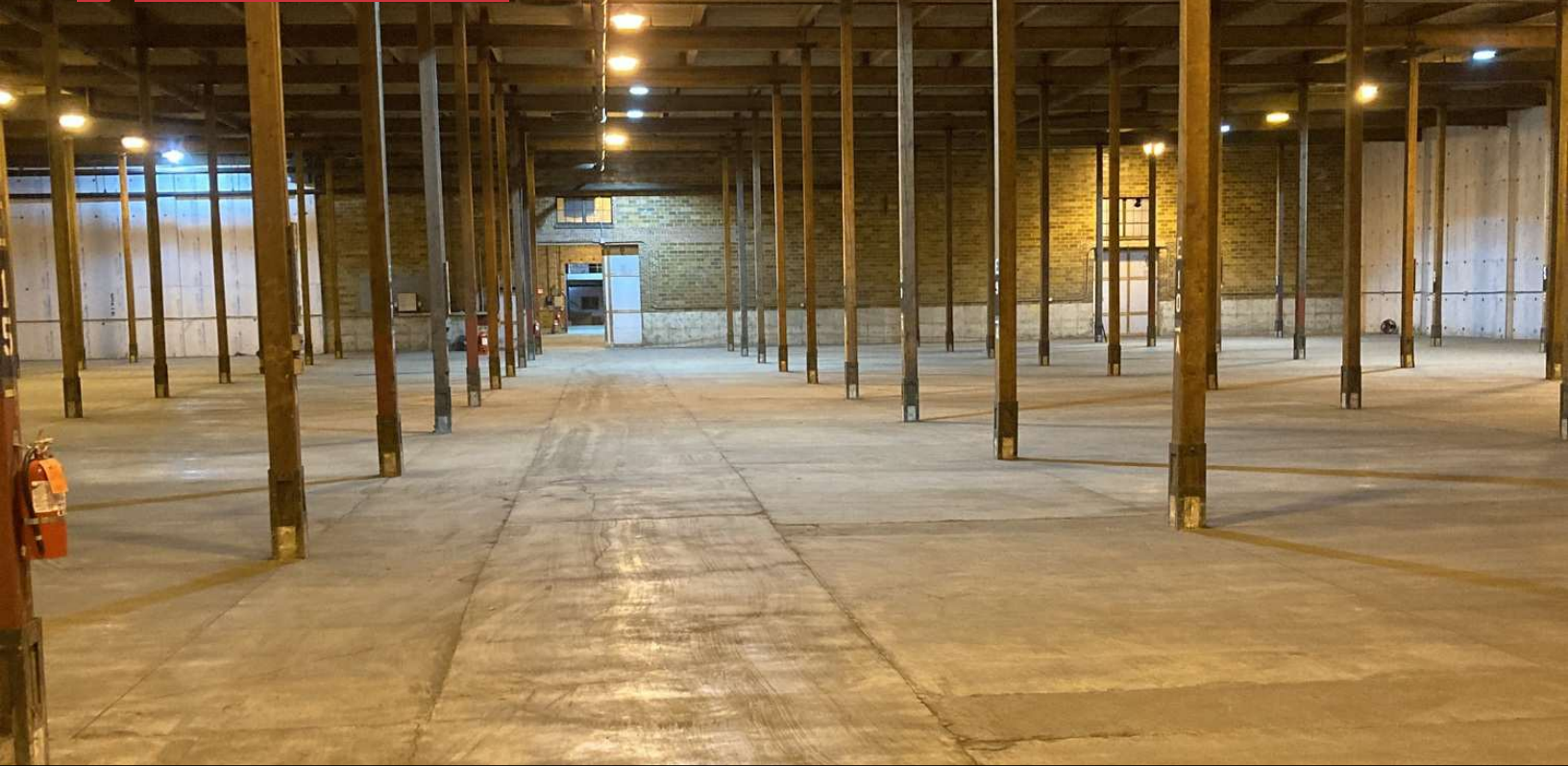

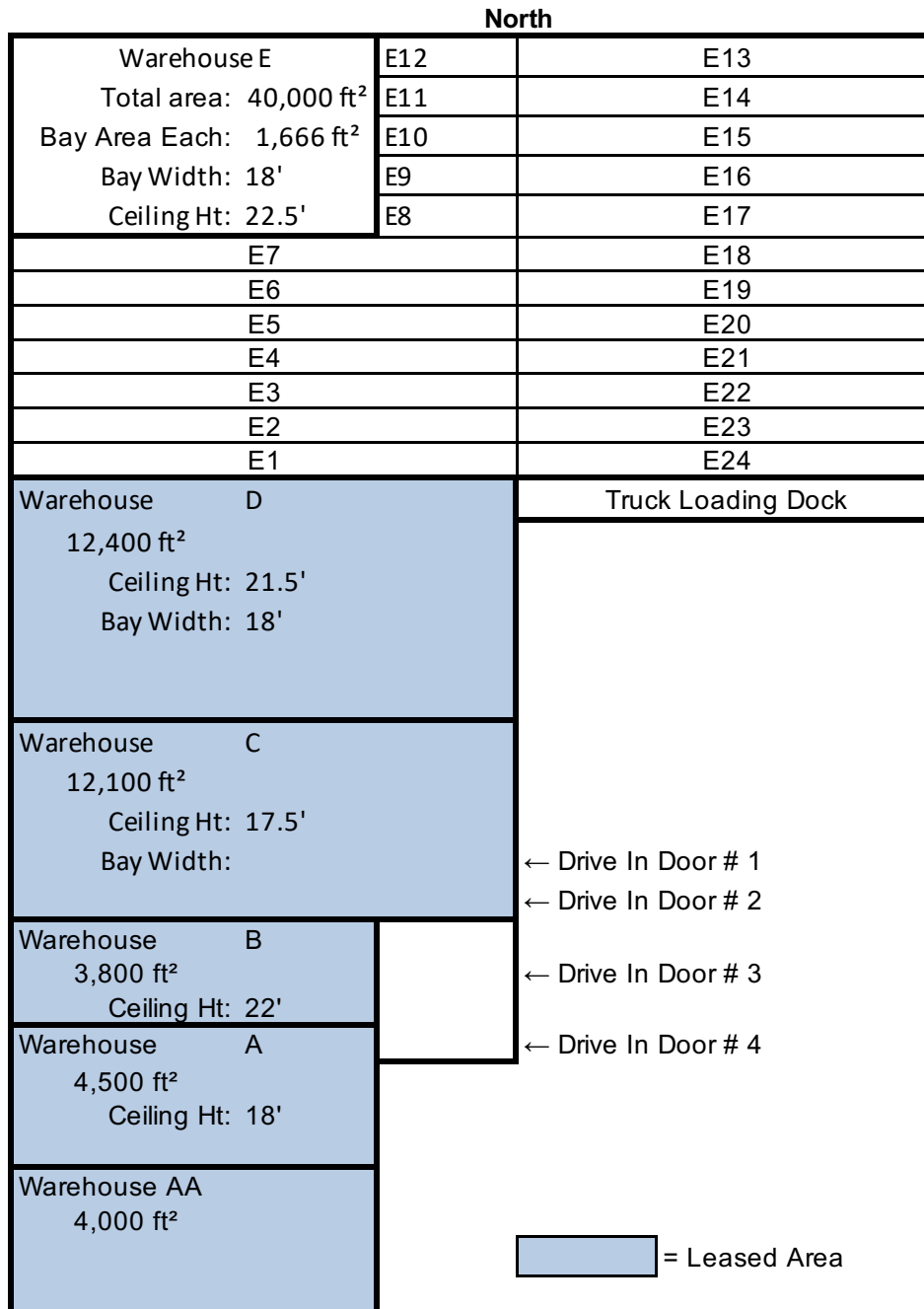

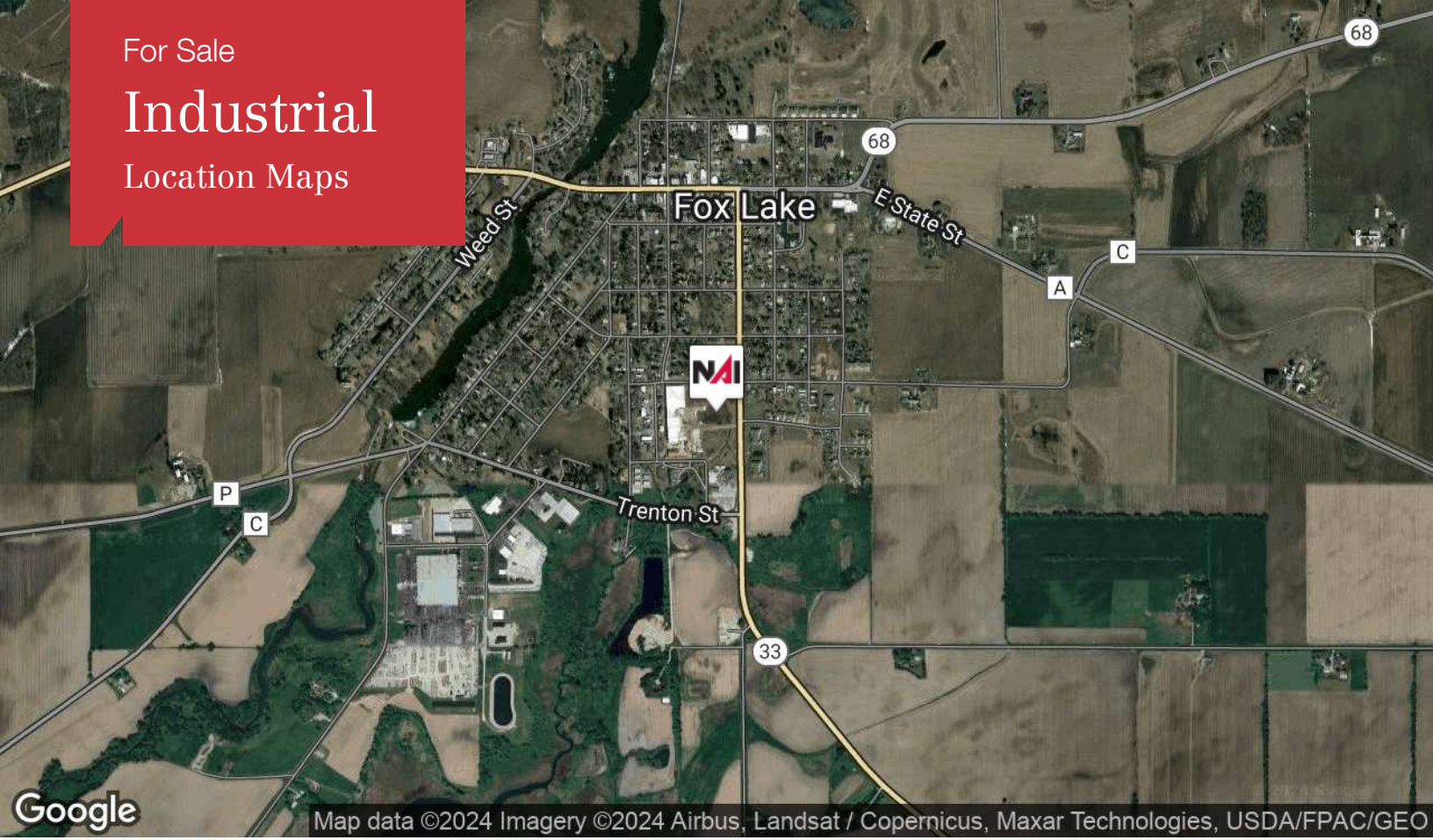
Parcel Map



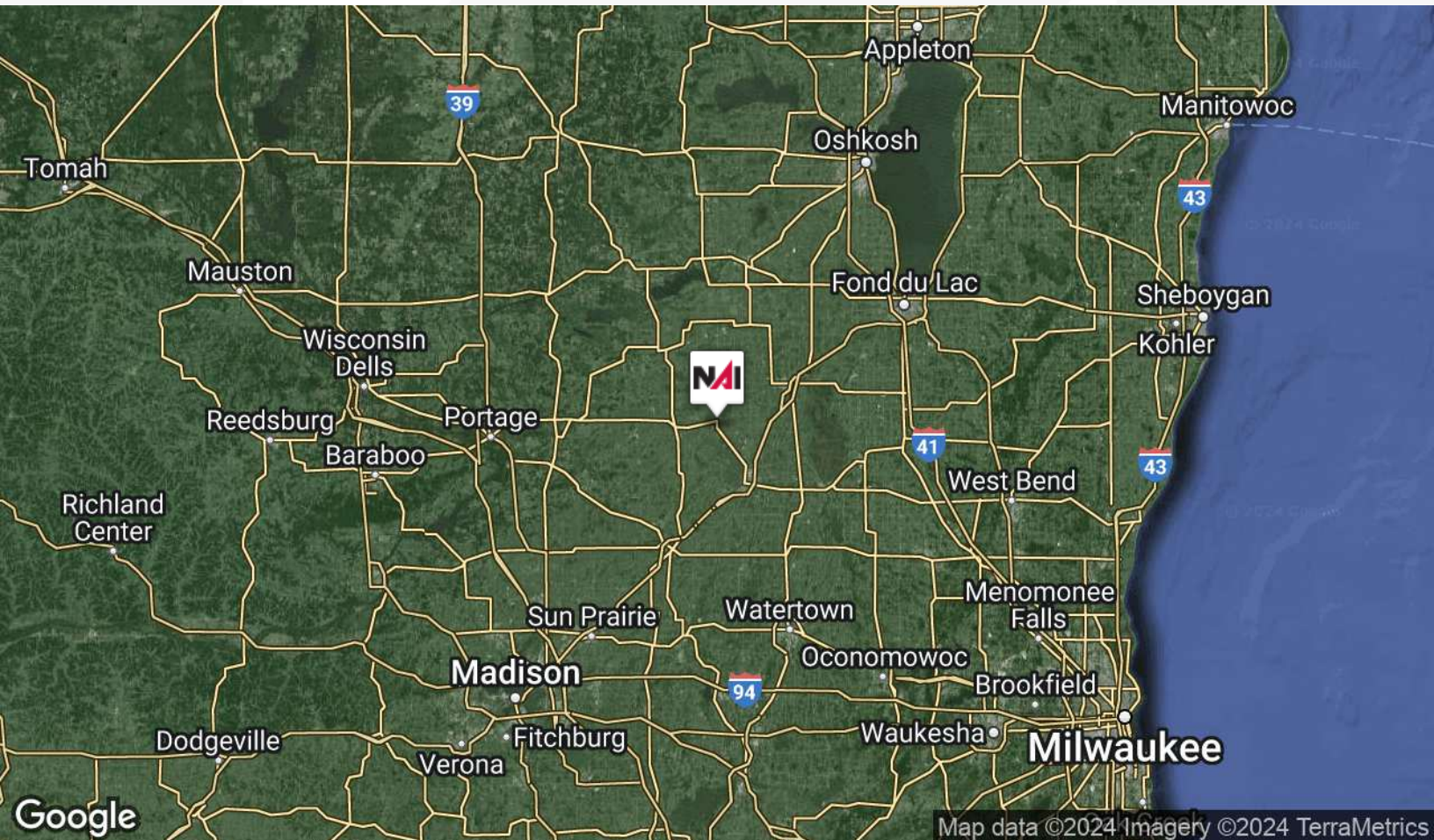

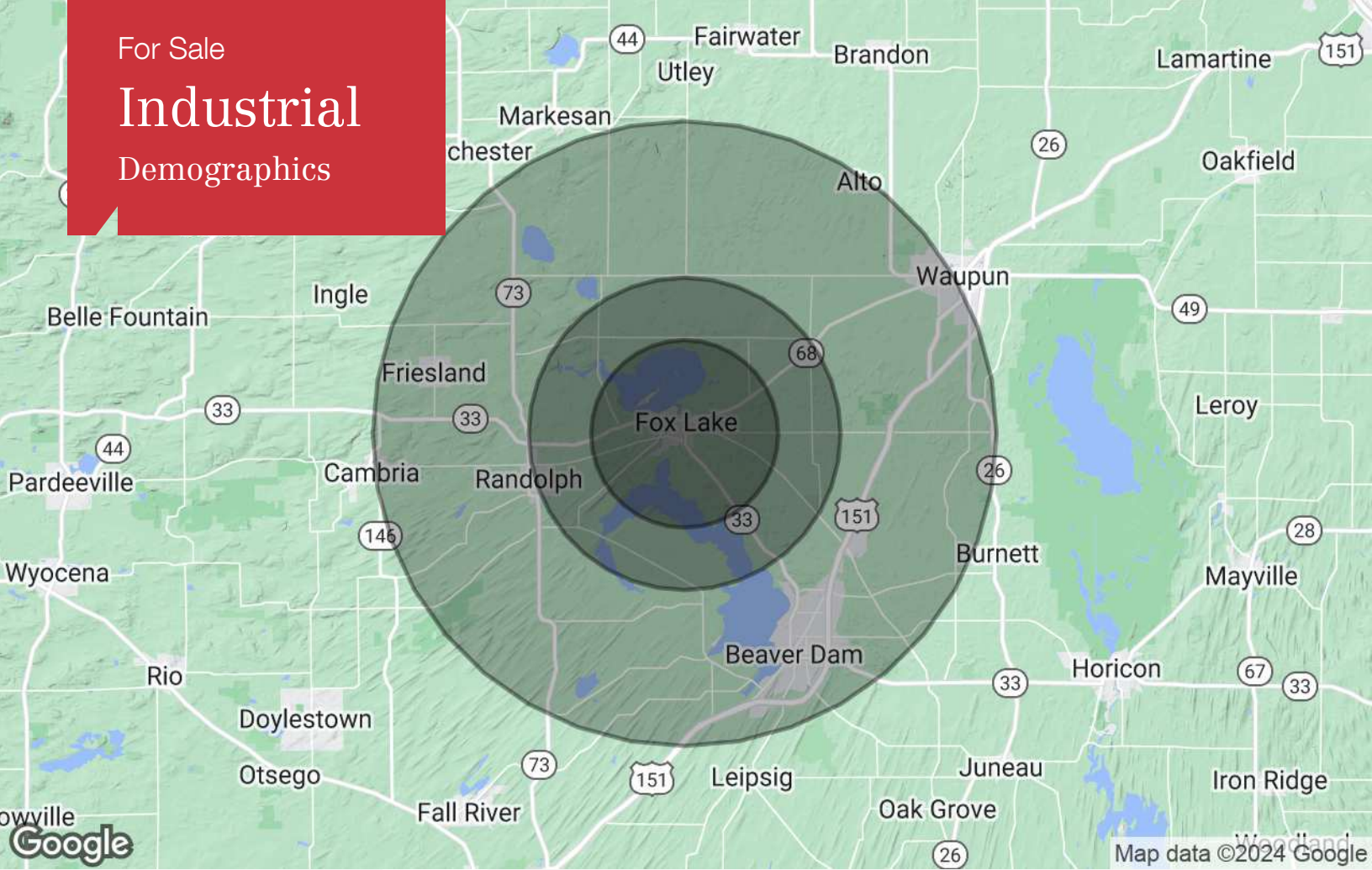
